The Committees on Local Government; Finance; Ways and Means; and Social Justice, Welfare and Rural Development to which were referred Senate Bill No. 12, introduced by Senator Ferdinand R. Marcos, Jr., and Senator Cynthia A. Villar entitled:

**"AN ACT
PROVIDING BARANGAY OFFICIALS, INCLUDING BARANGAY TANODS,
MEMBERS OF THE LUPON NG TAGAPAMAYAPA, BARANGAY HEALTH

and Senate Bill No. 1956, introduced by Senator Jinggoy Ejercito Estrada, entitled:


