The Committee on Finance to which was referred S.B. No. 963, introduced by Senator Jinggoy Ejercito Estrada, *entitled*:

#### AN ACT

FURTHER AMENDING SECTIONS THREE AND FOUR OF REPUBLIC ACT NO. 3456, AS AMENDED BY REPUBLIC ACT NO. 1177, OTHERWISE KNOWN AS THE "INTERNAL AUDITING ACT OF 1962."

has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

- 1. On page 1, Section 1, line 12, between the period (.) and the comma (.) delete the numbers "1177" and in lieu thereof insert the numbers "4177"
- 2. On the same page, line 24, after the word "The" delete the following: "COMMISSION ON AUDIT" and in lieu thereof insert the phrase "DEPARTMENT OF BUDGET AND MANAGEMENT (DBM)"
- 3. On the same page, line 26, before the word "policies" delete the word "general"
- 4. On the same page, line 29, between the words "The" and "shall" delete the word "COMMISSION" and in lieu thereof insert the acronym "DBM"
- 5. On the same page, under Section 2, lines 40 and 41, between the word "The" and the comma (,) delete the phrase "Commission on Audit, together with the Civil Service Commission and the Department of Budget and Management" and in lieu thereof insert the phrase "DBM AND THE COMMISSION ON AUDIT"
- 6. On page 2, line 4, between the words "The" and "shall" delete the phrase "Commission on Audit" and in lieu thereof insert the acronym "DBM"
- 7. Finally, the new title of Senate Bill No. 963, as amended, shall now read as follows:
