

No. 10633 otherwise known as the General Appropriations Act of 2014 the amount of Twenty Billion Pesos (P20,000,000,000) in programmed funds and Eighty Billion (P80,000,000,000) in unprogrammed funds were included for Rehabilitation and Reconstruction Program.
