Pursuant to Section 67, Rule XXIII of the Rules of the Senate, with the permission of the Body, upon motion of Senator Pimentel, only the title of the bill was read without prejudice to the insertion of its full text into the Record of the Senate.

Thereupon, the Chair recognized Senator Poe for the sponsorship.

## SPONSORSHIP SPEECH OF SENATOR POE

Senator Poe presented to the Body Committee Report No. 32 on Senate Bill No. 2239 which, she said, was a consolidation of Senate Bill Nos. 271, 349 and 1656 authored respectively by Senators Revilla, Legarda and herself, and in consideration of House Bill No. 925, introduced by Representatives Tieng, Velarde and Atienza, the approved version of the House of Representatives, which was referred to the Committee on Public Information and Mass Media. She also acknowledged Sen. Bam Aquino as one of the coauthors.

The full text of Senator Poe's sponsorship speech follows:

Senate Bill No. 2239 is entitled "An Act Requiring All Franchise Holders or Operators of Television Stations and Producers of Television Programs to Broadcast or Present their Programs with Closed Captions Option, and For Other Purposes." The legislation has the objective of allowing the deaf, deafened and hard of hearing individuals, access to a full variety of television programs through the aid of closed captions and, thus, permitting them to engage and be part of popular culture.

As defined in the proposed policy measure, closed-caption is a method of sub-titling television programs by coding statements as vertical interval signal that are decoded at the receiver

and superimposed at the bottom of the television screen. This is similar to the description written in the portal of Merriam-Webster that "closed-captioning" is a system of having written words that appear on the screen to describe what is being said for people who do not hear well. It can only be seen with a special receiver-equipped decoder.

At present, there is no reliable data as to what exact percentage of all persons with disabilities are deaf or hearing-impaired. At the very least, 1.4 million persons with hearing disabilities were reported in the latest census. In 2009, the reported deaf population was at 241,624 and those who are partially deaf at 275,912. A considerable 517,536 have limited access to media information because of hearing impairedness, as the Philippine Statistics Authority reported.

A study of the Department of Education (DepEd) indicated that 97% of children with disabilities are not in school and that of the same, around 13% have hearing loss or impairedness problem.

Closed-captioning is developed to aid hearing-impaired people, although it has since been used for a variety of other reasons:

- It provides a critical link to news, entertainment and information to individuals who are deaf or hard of hearing;
- The deaf culture is comprised of those who are deaf, hearing-impaired and the hearing world that interacts with them on a personal basis; and
- 3. Complete access to information, especially those relating to human rights issues lining the deaf community, is essential.

Its practicality can be seen in such noisy environment such as airports, or in places where there is a need to keep an environment quiet such as hospitals or libraries.

The following are the highlights of the legislation:

a. It mandates that all franchise holders or operators of television stations and producers of television programs to broadcast or present their programs with closed captions options. It means that the system of closed captioning includes the capability or option to hide or show the captions at the discretion of the viewers. It benefits not only the deaf but also those who have difficulty hearing or understanding the spoken words;

- b. It provides exemptions where closed-captioning may not apply;
- c. A system of penalty, so that this written legislation will not just be a scrap of paper but should be honestly pursued; and
- d. A provision on implementing rules and regulations. This is most significant as the system of closed-captioning is one that combines noble objective and technical implementation. I trust that in this phase, the MTRCB, NTC and the TV stations will devise mechanisms to fully realize the objectives and intents of this bill.

During the public hearing conducted by the committee on the legislation, the resource persons from the three big networks: ABS-CBN (Ms. Monalisa Manalo and Arlan Alfonso), GMA-7 (VP Lynn Delfin and VP Teresa Pacis), and TV-5 (Mr. Patrick Paez), all posited that the networks' technical capacity is competent enough to support a closed caption system, especially for pre-recorded, pre-scripted or canned shows.

This legislation is likewise consistent and a fulfilment of the Philippine government's commitment when it ratified the Convention on the Rights of Persons with Disabilities in 2008. Its provisions explicitly state that there should be full accessibility and recognition of the linguistic and cultural identity of persons with disability.

The country will also join the rest of its Southeast Asian neighbors — Indonesia, Malaysia and Thailand — in providing a closed-captioning system to help the deaf and the hearing-impaired community.

Dahil tamang impormasyon ang puwedeng magpayabong sa bayan. Ang sabi nga, "Information is the currency of democracy."

#### COSPONSORSHIP SPEECH OF SENATOR AQUINO

Senator Aquino echoed what Senator Poe said in her sponsorship speech, and he underscored the importance of the measure to the deaf and hearingimpaired Filipinos since closed captioning would enable them to keep in touch with public affairs and make them integrated in society.

Senator Aquino informed the Body of the visit to his office a few weeks ago of a number of deaf individuals and groups pushing for the closed caption measure and another bill which would mandate a Filipino sign language, especially in the absence of a universal Filipino sign language.

Senator Aquino stressed the need for another bill that would seek the inclusion of a sign language interpreter during newscasts similar to the '80s show, "Kapwa Ko Mahal Ko." He reiterated that this simple act would help deaf Filipinos keep in touch with public affairs and become updated with current events, similar to TV5 which has a sign language screen insert. He said that aside from closed caption, the integration of a Filipino sign language and sign language insert in newscast would hopefully be tackled in future bills.

Senator Aquino revealed that one of the alarming news that the deaf group told him was that more than 50% of deaf children are molested and/or abused primarily because the education system does not provide enough support for the deaf. Thus, he underscored the need to support measures that would provide the hearing-impaired with proper support and care, and to likewise help them integrate into society by assisting them to find jobs and become productive members of the society.

#### MANIFESTATION OF SENATOR POE

At this point, Senator Poe thanked Senator Aquino for supporting the measure, acknowledging his huge role in advocating for the hearing-impaired community. She gave assurance that she would work on a separate bill that would mandate a sign language option in news programs.

## SUSPENSION OF CONSIDERATION OF SENATE BILL NO. 2239

Upon motion of Senator Pimentel, there being no objection, the Body suspended consideration of the bill.

## ACKNOWLEDGMENT OF THE PRESENCE OF GUESTS

At this juncture, Senator Pimentel acknowledged the presence in the gallery of barangay officials and employees from Bgy. Fatima, General Santos City headed by Josephine P. Matobato, and the 2014 Miss Philippines Earth beauty titleholders, namely: Miss Philippines Air Diane Carmela Querrer, Ms. Philippines Water Kimberly Covert, and Miss IT Philippines Ecotourism Monique Teruelle Manuel.

Senate President Drilon welcomed the guests to the Senate.

#### SUSPENSION OF SESSION

Upon motion of Senator Pimentel, the session was suspended.

It was 3:59 p.m.

#### RESUMPTION OF SESSION

At 4:07 p.m., the session was resumed.

#### COMMITTEE REPORT NO. 33 ON SENATE BILL NO. 2159

(Continuation)

Upon motion of Senator Pimentel, there being no objection, the Body resumed consideration, on Second Reading, of Senate Bill No. 2159 (Committee Report No. 33), entitled

AN ACT AMENDING REPUBLIC ACT NO. 7721, OTHERWISE KNOWN AS AN ACT LIBERALIZING THE ENTRY AND SCOPE OF OPERATIONS OF FOREIGN BANKS IN THE PHILIPPINES AND FOR OTHER PURPOSES.

Senator Pimentel stated that the parliamentary status was the period of interpellations.

Thereupon, the Chair recognized Senator Osmeña, sponsor of the measure.

## TERMINATION OF THE PERIOD OF INTERPELLATIONS

There being no interpellation, upon motion of Senator Pimentel, there being no objection, the Body closed the period of interpellations.

#### MANIFESTATION OF SENATOR OSMEÑA

Senator Osmeña manifested his willingness to continue entertaining questions during the period of amendments. He appealed to the Body to pass the bill on Third Reading the following week so that both Houses could meet in a bicameral conference since the House of Representatives had already passed its version. He said that the bill is in keeping with the Philippines' commitment to join the ASEAN framework for banking institutions.

## SUSPENSION OF CONSIDERATION OF SENATE BILL NO. 2159

Upon motion of Senator Pimentel, there being no objection, the Body suspended consideration of the bill.

#### ADJOURNMENT OF SESSION

Upon motion of Senator Pimentel, there being no objection, the Chair declared the session adjourned until three o'clock in the afternoon of the following day.
