### A RESOLUTION

## DIRECTING THE SENATE COMMITTEE ON PUBLIC ORDER AND DANGEROUS DRUGS TO CONDUCT AN INQUIRY, IN AID OF LEGISLATION, ON THE 1,004 HIGH-POWERED FIREARMS THAT REPORTEDLY ENDED UP IN THE HANDS OF INSURGENT FORCES, WITH THE INTENT OF STRENGTHENING THE MANDATES OF GOVERNMENT AGENCIES AND DETERMINING THE APPROPRIATE GOVERNMENT RESPONSE TO LOOSE FIREARMS

WHEREAS, the Constitution provides that the maintenance of peace and order, the protection of life, liberty and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, President Benigno Simeon Aquino III reportedly disclosed in December 2013 that a cache of high-powered firearms was released to police auxiliaries and private security companies by a unit of the Philippine National Police after their papers were processed<sup>1</sup>;

WHEREAS, it was reported that the investigation prompted by the president's exposé revealed that a certain Mr. Isidro Lozada purchased 1,004 high-powered firearms through Twin Pines Incorporated and licensed them using the name of other juridical entities and under the pretense of manning mining firms in Mindanao<sup>ii</sup>;

WHEREAS, the firearms were allegedly sold in twenty-three (23) separate transactions<sup>111</sup> and delivered to Butuan City where they would be picked up by communist rebels in batches of 20 to 30 firearms over a period spanning 2011 to early 2013<sup>11</sup>;

WHEREAS, Mr. Lozada reportedly admitted that he facilitated the registration and delivery of rifles after being threatened by the elements of the New People's Army  $(NPA)^{v}$ ;

WHEREAS, reports indicate that five (5) of the forty-four (44) AK-47 rifles recovered by military forces after several encounters with the communist rebels were already confirmed to be part of the contentious rifles cache<sup>v1</sup>;

WHEREAS, the influx of loose firearms in the hands of insurgent forces undermines the security efforts of the government and compromises peace and safety in the country;

WHEREAS, there is a pressing need to identify the gaps in the implementation of firearm regulations in the country and to determine the appropriate measures to strengthen the Philippine Government's response to loose firearms;

*NOW THEREFORE, BE IT RESOLVED*, by the Philippine Senate, to direct the Senate Committee on Public Order and Dangerous Drugs to conduct an inquiry, in aid of legislation, on the 1,004 assault rifles that reportedly ended up in the hands of insurgent forces, with the intent of strengthening the mandates of government agencies and determining the appropriate government response to loose firearms.
