Recommending its approval with amendments.

MR. PRESIDENT:

The Committees on Labor, Employment and Human Resources Development; and Games, Amusement and Sports to which was referred S. No. 129, introduced by Senator Jinggoy Ejercito Estrada, entitled:

**"AN ACT
AMENDING PRESIDENTIAL DECREE NO. 442, AS AMENDED, OTHERWISE
KNOWN AS THE LABOR CODE OF THE PHILIPPINES BY ADDING A NEW
ARTICLE 287-A REDUCING THE RETIREMENT AGE OF RACE HORSE
JOCKEYS FROM SIXTY (60) TO FIFTY-FIVE (55)"**

have considered the same and have the honor to report it back to the Senate with the recommendation that the bill be approved with the following amendments:

1. On page 1, line 4, the numbers "287-A" after the word "Article" should be change to "291-A";
2. On the same page, line 5, the numbers "287-A" after the word "Art." should be change to "291-A";

3. On the same page again, line 11, the numbers "287" after the word "Art." should be change to "291";

4. On the same page and on the same line 11, after the word "code" but before the punctuation period ".", insert the phrase to read as follows:

"PROVIDED, THAT, HE SHALL PAY ADDITIONAL PREMIUM TO THE SSS, AS MAY BE PRESCRIBED IN THE IMPLEMENTING RULES AND REGULATIONS OF THIS ACT"

5. Finally, on the same page, in the fourth line of the Title of the Bill, after the word "Article" but before the word "Reducing", the numbers "287-A", should be change to "291-A".




