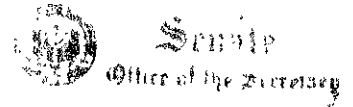

MR. PRESIDENT:

The Committees on Justice and Human Rights *and* Finance, to which was  
referred S. Jt. Res. No. 10, introduced by Sen. Francis G. Escudero, entitled:

**"JOINT RESOLUTION  
EXTENDING THE PERIOD FOR FILING OF CLAIMS FOR  
REPARATION OF HUMAN RIGHTS VIOLATIONS  
VICTIMS, UNDER REPUBLIC ACT NO. 10368,  
OTHERWISE KNOWN AS THE HUMAN RIGHTS VICTIMS  
REPARATION AND RECOGNITION ACT OF 2013, AND IN  
CONSEQUENCE THEREOF, THE EXISTENCE OF THE  
HUMAN RIGHTS VICTIMS' CLAIMS BOARD"**

Taking into consideration S. No. 2418, introduced by Sen. Teofisto "TG"  
Guingona III, entitled:

**"AN ACT  
EXTENDING THE DEADLINE TO FILE CLAIMS UNDER THE  
HUMAN RIGHTS VICTIMS REPARATION AND RECOGNITION ACT  
OF 2013 OR REPUBLIC ACT NO. 10368"**

have considered the same and have the honor to report it back to the Senate with the recommendation that the attached resolution, S. Jt. Res. No. 10, taking into consideration S. No. 2418, be approved with amendments, with Senators Escudero, Guingona *and* Pimentel as Authors thereof.

The amendments are as follows:

- 1.) On Page 2, delete the entire 2<sup>nd</sup> Paragraph;
- 2.) On Page 2, on the 3<sup>rd</sup> Paragraph, delete the phrase “as well as the life of the Board”;

Still on Page 2, on the 3<sup>rd</sup> Paragraph, change the word “it” between the words “allow” and “to” to “**the Board**”;

The 3<sup>rd</sup> Paragraph will now read as follows:

“WHEREAS, the extension of the period for filing of claims for reparation and recognition will allow the Board to fulfil its mandate and help enhance human rights as the vital nexus connecting the sacrifices and heroism of the past to building a fair and functioning Philippine society for tomorrow”;

- 3.) On Page 2, delete the entire 5<sup>th</sup> Paragraph;
- 4.) On Page 2, delete the entire 6<sup>th</sup> Paragraph;
- 5.) On Page 2, delete the entire 7<sup>th</sup> Paragraph; and
- 6.) In the title, delete the comma (,) after the year 2013, and delete the phrase “and in consequence thereof, the existence of the Human Rights Victims’ Claims Board”.

The title will now read as follows:

**“Joint Resolution  
Extending the Period For Filing of Claims For Reparation of Human  
Rights Violations Victims, Under Republic Act No. 10368,  
Otherwise Known as the Human Rights Victims Reparation and  
Recognition Act of 2013”**
