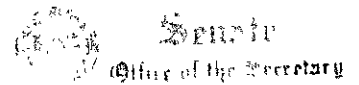

recommendation that the attached S. B. No. 2488, prepared by the Committees, *entitled*:


