

AN ACT

INCLUDING THE NATIONAL YOUTH COMMISSION CHAIRPERSON AS A MEMBER OF THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 10121, OTHERWISE KNOWN AS THE PHILIPPINE DISASTER RISK REDUCTION AND MANAGEMENT ACT OF 2010

EXPLANATORY NOTE

The Constitution, Article 2, Section 13 provides:

The State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs.

The United Nations International Strategy for Disaster Reduction (UNISDR) acknowledges the role of the youth in disaster risk reduction. In the 2000 United Nations World Disaster Reduction Campaign, the UNISDR declared that the youth "represent powerful sources for change and for mobilization. They occupy a central place in promoting a necessary change in behaviours and a shift in mentalities, if a successful disaster prevention and risk management are to be achieved. Young people should be given the chance to ensure their own protection and the protection of their world, through appropriate education and level of responsibility in the decision-making process."

There are three main reasons why youth participation in disaster risk reduction matters: First, to be nurtured, protected, and treated with respect, and, to be consulted and involved are considered a right that our youth cannot be denied of. Second, to improve

the services for the youth, one of the sectors of society who are gravely affected in times of disaster, their views and interests must be well articulated and represented. Lastly, there are developmental benefits from youth participation, not only for the youth themselves but also for the whole society.²

The youth comprise a fifth of our country's population. Indeed, they are a "valuable resource for risk communication, education, advocacy, and help with practical risk reduction activities." Their innovative ideas, eagerness to learn and act, and social networks are a few of what the youth can offer to strengthen our country's disaster risk reduction and management efforts.


This bill seeks to make the youth partners in disaster risk reduction at a national level. It proposes to include a representative of the youth in the National Disaster Risk Reduction and Management Council so as to empower them with coordination, integration, supervision, monitoring and evaluation functions, and more importantly, to engage them in a more valuable role of policy-making.
