#### AN ACT

### ESTABLISHING THE PHILIPPINE GOAT AND SHEEP CENTER

#### **EXPLANATORY NOTE**

There is a need for the government to push for programs maximizing productivity in the countryside and making the Filipino farmers self-reliant through backyard animal raising that complements their regular farm production.

It is common to see Filipinos raise cattle, swine, poultry and other animals, but very few are seen raising goats and sheep, even though this is a very promising alternative source of milk, meat and fiber.

There is a need for government initiative to conserve, improve and develop the Philippine goat and sheep to enable the farmers, especially the smallholder farmers, to avail themselves of good quality goats and sheep stock at all times and at reasonable prices through an organized program of breeding and development.

By encouraging backyard goat and sheep development in the rural areas, we can drastically reduce the importation of milk and milk products while ensuring a steady source of food and additional income for our farmers.

Thus, the need for the establishment of the Philippines Goat and Sheep Center at the Central Luzon State University in the Science City of Munoz, Nueva Ecija, and possibly in other strategic areas of the country has become imperative.

Passage of this bill is earnestly sought.

# ESTABLISHING THE PHILIPPINE GOAT AND SHEEP CENTER

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 2	SECTION 1. Short Title - This Act shall be known as the "Philippine Goat and Sheep Act of 2015".

23		SEC. 3. Definition of Terms As used in this Act, the following terms

26	a.	Philippine Goat and Sheep Center - refers to the Philippine Goat and
27		Sheep Center in the Central Luzon State University, the other goat and
28		sheep centers in Luzon, Visayas and Mindanao, and those that will be
29		created pursuant to this Act;

31	b.	Crossbred - refers to the offspring of two (2) purebred animals;

33	C.	Performance Testing - refers to the systematic selection of the best
34		animal from a population raised under the same environment. The basic
35		consideration is its genetic potential;

d. Research Network - refers to the Philippine Council for Agriculture, Forestry and Natural Resources Research and Development (PCARRD), Department of Agriculture and private organization conducting researches geared towards developing technology that will increase productivity of smallholder farmers;

- e. Smallholder Farmers are basically farmers owning below twenty (20) heads of goats or sheep;
- f. Upgraded refers to the offspring of a cross between a native stock and an exotic breed of animal.

**SEC. 4.** Scope. - The activities of the Philippine Goat and Sheep Center encompass all research and development efforts in all disciplines that lead to the improvement of the over-all productivity of the Philippine goat and sheep. In addition, research efforts to increase the annual population growth rate of small ruminants to meet existing and future demand shall be pursued;

SEC. 5. Priorities. - Research and development efforts in the areas of 21 22 biotechnology, breeding, nutrition, reproduction, animal health and product 23 development utilization, socio-economics, technology promotion and 24 environmental impact shall take priority. Research activities geared towards 25 development of appropriate technologies shall be the primary concern. These 26 technologies are those that would increase productivity of the goat and sheep in 27 a cost effective, simple and practical manner. Socio-economic researches shall 28 be undertaken hand in hand with the development of the technologies to ensure 29 economic appropriateness and acceptance of the technology by farmers. 30 Development of goat and sheep with improved performance as milk-meat 31 animals shall be the main focus in breeding. Development of feeding systems for 32 backyard and semi-commercial production, nutrition, improving reproductive 33 efficiency, physiology and schemes to reduce losses by parasites and diseases 34 shall likewise receive priority. Emphasis shall be put on technology transfer on 35 the developed appropriate technologies.

**SEC. 6.** *Philippine Goat and Sheep Center Board*. - The Advisory Board shall formulate policies and oversee the implementation of the Philippine Goat and Sheep Center, in consonance with the National Research and Development policies. The Philippine Goat and Sheep Center Advisory Board shall be composed of the following:

53 The CLSU President shall be the Chair, the Director of DA-BAI shall be the 54 Vice-Chair, while the Executive Director of the Philippine Goat and Sheep Center 55 shall serve as the Ex-Officio Secretary.

1 SEC. 7. Implementation and Coordination of the Program of the CLSU. -2 The Philippine Goat and Sheep Center Board shall be tasked to coordinate and 3 monitor the implementation of the program. It shall identify, through the 4 Department of Agriculture, the Director of the Philippine Goat and Sheep Center 5 and Project Leaders from various implementing stations of the research and 6 development projects in the areas of breeding, nutrition, animal health, 7 reproductive physiology, socio-economics, techno-transfer, product development 8 and utilization and environmental impact assessment. It shall formulate strategies 9 relative to the performance testing of bucks and rams, multiplication and 10 distribution of elite germplasm purebreds, crossbreds and native bucks and 11 rams. There shall be satellite centers in the islands of Luzon, Visayas and 12 Mindanao. The center in Luzon shall be the Central Luzon State University 13 (CLSU) in Nueva Ecija. The center in Visayas shall be the Visayas State 14 University (VSU) in Leyte. The center in Mindanao shall be the DA-Bagalupa 15 Stock Farm in Zamboanga del Sur.

17 The CLSU in Nueva Ecija shall be the Philippine Goat and Sheep National 18 Center which specializes in the development of breeding system of the goat and 19 sheep of smallholder farmers with exotic breeds and shall specialize in the 20 breeding of purebred small ruminants and its crossbreds and generation of 21 technology on goat dairying and sheep fiber. Furthermore, the center shall 22 specialize in the development of technology on nutrition, reproductive physiology, 23 animal health, product development and utilization, socio-economics and techno-24 transfer.

26 The other centers shall take responsibility of the regional research needs 27 and spearhead implementation of development activities in their respective 28 geographical area of responsibility. It shall include field testing and verification of 29 technologies developed by the national center.

32 SEC. 8. Farmers' Participation. - The farmer cooperators shall be 33 encouraged to strengthen existing farmers' cooperatives or establish strong 34 farmers association to serve as focal point for government assistance, production 35 and multiplication of upgraded small ruminants and on the dissemination of new 36 knowledge on goat dairying and fiber production from sheep.

39 SEC. 9. Funding. - To fund the Philippine Goat and Sheep Center, the 40 amount of Twenty Million Pesos (Php20,000,000.00) shall be appropriated by the 41 Department of Budget and Management from the unexpended balance of the 42 National Treasury and thereafter, shall be included in the General Appropriations 43 Act. The salaries of permanent staff and maintenance and operating budget shall 44 be appropriated and released directly to the various agencies of the Philippine 45 Goat and Sheep Center Network, in accordance with the approved program of 46 activities. 47

48 Any income derived from the sale of goats and sheep shall be placed in a 49 revolving fund to be used in the propagation and distribution of goat and sheep. 50

52 SEC. 10. Repealing Clause. - All provisions of law, presidential decrees 53 or issuances, orders, including rules and regulations inconsistent herewith are 54 hereby repealed or modified accordingly.

**SEC. 11.** *Effectivity.* - This Act shall take effect after fifteen (15) days following the completion of its publication in the *Official* Gazette or in at least two (2) newspapers of general circulation. 1 2 3 4 5 6 7 8 9
