AMENDING TITLE V – BOOK III OR REPUBLIC ACT 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1999, PROPOSING A PERMANENT ITEM FOR A DISASTER OFFICER IN EVERY LOCAL GOVERNMENT UNIT

#### **EXPLANATORY NOTE**

The Philippines is prone to dangerous typhoons, earthquakes, volcanic eruptions and other natural disasters. This is because its location is along the Pacific Ring of Fire.

Last November 2013, the country was hit by a destructive natural disaster – Typhoon Yolanda (Haiyan). Based on the latest report of the National Disaster Risk Reduction and Management Council (NDRRMC) dated April 17, 2014, the destruction caused by Yolanda was reportedly 6,300 deaths, 1,061 people remain missing while 28,689 others were injured. Also, last October 2013 we experienced the ferocity of the 7.2 magnitude earthquake in Bohol that caused an unimaginable damage of 222 deaths. These experiences have been too difficult for the Filipino people. Such incidents show that we are in dire need of a systematic disaster risk reduction and response mechanism which in our case is a decentralized one. Being a decentralized system, a local disaster officer is required to lead, organize, and manage permanent support in every Local Government Unit, especially it times of emergencies.

Republic Act 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 states in section 3 that the National Disaster Risk Reduction and Management Framework (NDRRMF shall provide community-based disaster risk reduction and management, a process of disaster risk reduction and management in which at risk communities are actively engaged in the identification, analysis, treatment, monitoring and evaluation of disaster risks in order to reduce their vulnerabilities, and enhance their capacities. It also puts the people at the heart of decision-making and implementation of disaster risk reduction and management activities; and provide for comprehensive, all hazards, multi-sectoral, inter-agency and community-based approach to disaster risk reduction and management. In this light, it is significant that each local government shall assign a disaster risk officer with a permanent status and be required to establish an office that is exclusively for disaster risk operations. With this, it will be easier to satisfy the purpose in providing assistance in their respective communities in times of devastation, and for those affected people to easily move forward and go back to their normal life.

This bill seeks to assign a permanent Disaster Risk Officer in each Local Government Unit. With this, every local government unit's organizational structure will

be more dynamic, efficient and each will have an operating mechanism that will meet the needs and service requirements of every community.

In this regard, passage of this bill is earnestly sought.

This Act shall take effect fifteen (15) days after its publication in the 7 Official Gazette or in two (2) newspapers of general circulation. 8 9 SECTION 4. This Act shall take effect fifteen (15) days after its publication in at least two (2) newspapers of general circulation. 10
