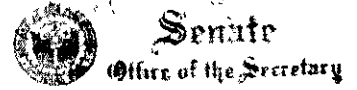


RESOLUTION  
DIRECTING THE PROPER SENATE COMMITTEE  
TO CONDUCT AN INQUIRY, IN AID OF LEGISLATION,  
ON THE REPORTED INVESTMENT SCAM ALLEGEDLY  
PERPETRATED BY ONE DREAM GLOBAL MARKETING, INC.

1 WHEREAS, the Constitution, Section 5 provides: “The maintenance of peace and order,  
2 the protection of life, liberty, and property, and promotion of the general welfare are essential for  
3 the enjoyment by all the people of the blessings of democracy”;

4 WHEREAS, the *The Philippine Daily Inquirer* on 22 July 2015 reported that a complaint  
5 for syndicated estafa has been filed against One Dream Global Marketing, Inc. after it allegedly  
6 duped thousands of investors of almost ₱3 billion;

7 WHEREAS, complainant Christian Salazar and his wife alleged that officers and  
8 employees of One Dream Global Marketing, Inc. closed the office on 11 July 2015 and brought  
9 with them ₱12.7 million worth of investments from his group of 300 investors;

10 WHEREAS, the company allegedly employed a pay-in and pay-out scheme, where an  
11 investor is involved in product selling but pays in ₱888 for one slot, and upon exit after four days  
12 the company pays out of ₱1,300;

13 WHEREAS, there were also alleged incentives for hardworking members who would  
14 bring recruits to earn a discounted rate of ₱44 per slot for every referral made;

15 WHEREAS, One Dream Global Marketing, Inc. is only one of many investment scams  
16 being reported in the media;

17 WHEREAS, among various strategies employed by people involved in several other  
18 scams are telling rags-to-riches stories, promise of high profit in so short a time, and, in some  
19 cases, giving out all-expense packages such as travel to encourage prospective victims to invest;

20 WHEREAS, Congress must determine the need for new or stronger legislation to stop the  
21 proliferation of investment scams;

1           WHEREFORE, BE IT HEREBY RESOLVED BY THE PHILIPPINE SENATE to direct  
2 the proper Senate committee to conduct an inquiry, in aid of legislation, on the reported  
3 investment scam allegedly perpetrated by One Dream Global Marketing, Inc.
