RESOLUTION DIRECTING THE PROPER SENATE COMMITTEE TO CONDUCT AN INQUIRY, IN AID OF LEGISLATION, ON THE COMMISSION ON AUDIT REPORT THAT THE QUEDAN AND RURAL CREDIT GUARANTEE CORPORATION CONTINUES TO INCUR LOSSES FROM ITS OPERATIONS AMOUNTING TO ₽11.5 BILLION IN 2014

1 WHEREAS, the Constitution, Article 11, Section 1 provides:

2 Section 1. Public office is a public trust. Public officers and employees 3 must, at all times, be accountable to the people, serve them with utmost 4 responsibility, integrity, loyalty, and efficiency; act with patriotism and justice, 5 and lead modest lives;

6 WHEREAS, the Commission on Audit (COA) stated in its 2014 Audit Report that the
7 Quedan and Rural Credit Guarantee Corporation (Quedancor) continues to incur losses from its
8 operations amounting to #11.5 billion from 2006 to 2014;

- 9 WHEREAS, Quedancor is a non-bank financial institution mandated to accelerate the 10 flow of investments and credit resources so as to trigger growth and development, rural 11 productivity and enterprises;
- 12 WHEREAS, it is likewise mandated to generate more livelihood and income 13 opportunities to farmers, fisherfolks and other rural entrepreneurs;
- 14 WHEREAS, the COA emphasized that the losses cast doubt on Quedancor's financial15 stability to be able to operate as a going concern;
- WHEREAS, state auditors observed that the financial performance of Quedancor needs improvement to meets its obligations and sustain its capability to provide guarantee on loan programs;
- WHEREAS, the COA noted that the financial charges of Quedancor indicate that due and
 demandable loans are hardly settled, while its bad debts show that loans receivable are hardly
 collected;
- 22 WHEREAS, Congress must implement measures that ensure effective performance of 23 government agencies of their mandated functions;

WHEREFORE, BE IT HEREBY RESOLVED BY THE PHILIPPINE SENATE to direct
 the proper Senate committee to conduct an inquiry, in aid of legislation, on the Commission on
 Audit Report that the Quedan and Rural Credit Guarantee Corporation continues to incur losses
 from its operations amounting to #11.5 billion in 2014.
