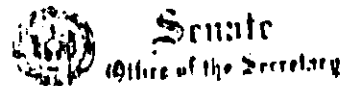

The Committees on Health and Demography and Finance, to which were referred House Bill No. 5852, introduced by Rep. Adiong, Salimbangon, Rodriguez (I.), Hernandez, Velasco, Tejada, Guiao, Roque, Abueg, Amatong (I.), Arenas, Plaza, Reyes, Gonzales, Manalo, Aragonés, Rodriguez (R.), Flores, Señeres, Gutierrez, Bulut-Begtang, Santiago, Espina and Advincula, entitled:

"AN ACT UPGRADING THE WAO DISTRICT HOSPITAL IN THE MUNICIPALITY OF WAO, PROVINCE OF LANA O DEL SUR AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 3607, ENTITLED AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF ONE GENERAL HOSPITAL IN EACH OF THE MUNICIPALITIES OF BAYANG, TAMPARAN AND WAO, ALL IN THE PROVINCE OF LANA O DE SUR, AND TO AUTHORIZE THE APPROPRIATION OF FUNDS THEREFOR"


have considered the same and have the honor to report it back to the Senate with the recommendation that the attached House Bill no. 5852, Introduced by Rep. Adiong, Salimbangon, Rodriguez (I.), Hernandez, Velasco, Tejada, Guiao, Roque, Abueg, Amatong (I.), Arenas, Plaza, Reyes, Gonzales, Manalo, Aragon, Rodriguez (R.), Flores, Señeres, Gutierrez, Bulut-Begtang, Santiago, Espina and Advincula, be approved with the following amendments, to wit:

1. on page 2, lines 1-5 delete the entire SEC 2 and replace it with;

SEC. 3. "The necessary funds to support the increase in bed capacity of the WAO District Hospital and the corresponding upgrading of its facilities and services, shall be included in the Annual General Appropriation Act of the year following its enactment under the direct supervision and control of the Department of Health – Autonomous Region Muslim Mindanao (DOH – ARMM). The DOH Secretary shall include in the Department's subsidy program, support for the capital outlay requirements of the hospitals".





AN ACT UPGRADING THE WAO DISTRICT HOSPITAL IN THE MUNICIPALITY OF WAO, PROVINCE OF LANAOS DEL SUR AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 3607, ENTITLED "AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF ONE GENERAL HOSPITAL IN EACH OF THE MUNICIPALITIES OF BAYANG, TAMPARAN AND WAO, ALL IN THE PROVINCE OF LANAOS DEL SUR, AND TO AUTHORIZE THE APPROPRIATION OF FUNDS THEREFOR"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The bed capacity of the Wao District Hospital located in
2 the Municipality of Wao, Province of Lanaos del Sur is hereby increased from
3 twenty-five (25) to seventy-five (75) beds.

4 SEC. 2. The existing hospital facilities, service capability, professional
5 health care services, and health human resource of the Wao District Hospital
6 shall be upgraded and increased to conform with and be commensurate to the
7 increase in bed capacity as herein provided.

1 **SEC. 3.** The Provincial Government of Lanao del Sur shall provide the
2 necessary funds to support the increase in bed capacity of the Wao District
3 Hospital and the corresponding upgrading of its facilities and services.
4 The Secretary of Health shall include in the Department's subsidy program,
5 support for the capital outlay requirements of the hospital.

6 **SEC. 4.** Sections 1 and 2 of Republic Act No. 3607 are hereby
7 amended.

8 **SEC. 5.** This Act shall take effect fifteen (15) days after its publication
9 in the *Official Gazette* or in a newspaper of general circulation.
