AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY RIZAL IN THE CITY OF MAKATI

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Creation of Barangay Rizal. — There is hereby created a barangay to be known as Barangay Rizal in the City of Makati.

SEC. 2. Conduct. and Supervision of Billiams.

SEC. 2. Conduct and Supervision of Plebiscite. — The plebiscite conducted and supervised by the Commission on Elections (COMELEC) pursuant to Ordinance No. 96-010 of the Sangguniang Panlungsod of the City of Makati, which ratified the creation of Barangay Rizal as proclaimed by the Plebiscite Board of Canvasser on 29 June 1996, shall serve as substantial compliance with the plebiscite requirement under Section 10 of Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991.

SEC. 3. Barangay Officials. — The incumbent elected barangay officials of Barangay Rizal, City of Makati shall continue to hold office until such time that their successors have been duly elected and qualified.

1	SEC. 4. Public Infrastructures and Facilities All existing public
2	infrastructures and facilities for public use existing therein at the time of the
3	approval of this Act are hereby transferred without cost or compensation to and
4	shall be administered by the new barangay.
5	SEC. 5. Internal Revenue Allotment Shares Barangay Rizal shall be
б	entitled to Internal Revenue Allotment shares pursuant to Section 285 of
7	Republic Act No. 7160, as amended, otherwise known as the Local
8	Government Code of 1991.
9	SEC. 6. Effectivity Clause This Act shall take effect fifteen (15)
0	days after its publication in any newspaper of general circulation.
