



**AN ACT ESTABLISHING THE THIRD DISTRICT ENGINEERING
OFFICE IN THE MUNICIPALITY OF MATALAM, PROVINCE OF
NORTH COTABATO AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** There shall be established, under the supervision of the
2 Department of Public Works and Highways, a third district engineering office
3 to be located in the Municipality of Matalam, Province of North Cotabato to
4 be known as the North Cotabato Third District Engineering Office.

5 **SEC. 2.** The said district engineering office shall serve the
6 municipalities of Banisilan, Carmen, Kabacan, Matalam, Miang and Tulunan,
7 all in the Third Congressional District of the Province of North Cotabato.

8 **SEC. 3.** The Secretary of Public Works and Highways shall include in
9 the Department's program the operationalization of the North Cotabato Third
10 District Engineering Office, the funding of which shall be included in the
11 annual General Appropriations Act.

1 SEC. 4. This Act shall take effect fifteen (15) days after its publication
2 in the *Official Gazette* or in a newspaper of general circulation.
