





AN ACT ESTABLISHING THE SECOND DISTRICT ENGINEERING
OFFICE IN THE MUNICIPALITY OF COMPOSTELA, PROVINCE
OF COMPOSTELA VALLEY AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established, under the supervision of the
2 Department of Public Works and Highways, a second district engineering
3 office to be located in the Municipality of Compostela, Province of
4 Compostela Valley to be known as the Second District Engineering Office.

5 SEC. 2. The Second District Engineering Office shall serve the
6 municipalities of Monkayo, Compostela, New Bataan, Montevista and
7 Maragusan, all located in the First Legislative District of the Province of
8 Compostela Valley.

9 SEC. 3. The Secretary of Public Works and Highways shall include in
10 the Department's program the operationalization of the Second District

1 Engineering Office, the funding of which shall be included in the annual
2 General Appropriations Act.

3 SEC. 4. This Act shall take effect fifteen (15) days after its publication
4 in the *Official Gazette* or in a newspaper of general circulation.
