Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There shall be established, under the supervision of the
Department of Public Works and Highways, a second district engineering
office to be located in the Municipality of Compostela, Province of
Compostela Valley to be known as the Second District Engineering Office.

5 SEC. 2. The Second District Engineering Office shall serve the 6 municipalities of Monkayo, Compostela, New Bataan, Montevista and 7 Maragusan, all located in the First Legislative District of the Province of 8 Compostela Valley.

9 SEC. 3. The Secretary of Public Works and Highways shall include in 10 the Department's program the operationalization of the Second District 1 Engineering Office, the funding of which shall be included in the annual
