

AN ACT TRANSFERRING THE LOCATION OF THE SORSOGON
SECOND DISTRICT ENGINEERING OFFICE FROM BULAN,
SORSOGON TO GUBAT, SORSOGON, AMENDING FOR THE
PURPOSE REPUBLIC ACT NO. 9689

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. Section 1 of Republic Act No. 9689 is hereby amended to
2 read as follows:

3 "SECTION 1. There shall be established, under the
4 supervision of the Department of Public Works and Highways, a
5 second district engineering office in the Second Congressional
6 District of the Province of Sorsogon to be located in the
7 Municipality of [Bulan] GUBAT, to be known as the Sorsogon
8 Second District Engineering Office."

1 SEC. 2. All other laws, decrees, executive orders and other issuances
2 that are inconsistent with this Act are hereby repealed.

3 SEC. 3 This Act shall take effect fifteen (15) days after its publication
4 in the *Official Gazette* or in a newspaper of general circulation.
