RESOLUTION

COMMENDING THE MINORITY LEADER, THE HONORABLE JUAN PONCE ENRILE, FOR HIS INVALUABLE AND DEDICATED SERVICE TO THE SENATE AND THE FILIPINO PEOPLE DURING HIS TERMS AS SENATOR

WHEREAS, the Honorable Juan Ponce Enrile, a dedicated public servant and advocate of sincere, competent and responsive governance, has served as Senator for four (4) terms of office (1987-1992; 1995-2001; 2004-2010 and 2010-2016);

WHEREAS, under his leadership, the Senate passed a number of vital economic and social legislations such as the CARP Extension, the Anti-Torture Act, the Expanded Senior Citizens Act, the Anti-Child Pornography Act, the National Heritage Conservation Act, and the Real Estate Investment Act;

WHEREAS, faithful to his promise to serve the Filipino people with utmost dedication and competence and to uphold and assert the independence and integrity of the Senate as an institution, he discharged his duties and responsibilities and honor, dedication and fairness to all members as Presiding Officer of the Senate sitting as an Impeachment Court to try and decide on the impeachment case of Former Supreme Court Justice Renato C. Corona where he has presided with impartiality and fairness;

WHEREAS, after he had stepped down as the Senate President on 5 June 2013, he assumed the role of Minority Leader and rigorously participated in the floor deliberations of important measures aimed at improving the general welfare of the people;

WHEREAS, his immeasurable contributions to the 13th, 14th, 15th and 16th Congresses have been highly instrumental to the Chamber's outstanding achievement: Now, therefore, be it
