#### EXPLANATORY NOTE

In the past, the main causes of mortality are infectious diseases even in the most developed countries. Now mass immunization programs have made a remarkable impact on preventive medicine all over the world. Carrying out significant impact on the reduction of mortality and in diphtheria and tetanus cases in most of the industrialized world is the primordial aim of these programs.

Since the early 1990s, the Philippines government has promoted immunizations and vitamin A supplementation. At one time, nearly 90 percent of children aged six and younger were covered. In spite of this success, the lives of thousands of the most impoverished children in the country remain threatened by diseases that can easily be prevented. The gap is growing between these imperiled young children and those living in the industrialized world who have life-saving vaccines readily available. According to the World Health Organization vaccination saves the lives of three million children throughout the world every year, yet another two million children die because they do not have access to existing vaccines.

This bill proposes that through government hospitals, satellite offices, accredited government clinics and other medical institutions, a comprehensive vaccination program that will provide free vaccination services to infants and children be established. The program shall be administered by the Department of Health. Immunization goes beyond simply protecting the individual. It also aims to improve the health of entire

communities by limiting the spread of infectious disease among children and adults. By these thoughts, the prompt passage of this bill is earnestly sought.

AN ACT  
ESTABLISHING A COMPREHENSIVE VACCINATION AND  
IMMUNIZATION PROGRAM FOR FILIPINO INFANTS AND  
CHILDREN, PROVIDING FUNDS THEREFOR AND FOR OTHER  
PURPOSES

*Be it enacted by the Senate and the House of Representatives of the Philippines in  
Congress assembled:*

1           **SECTION 1. Title.** This Act shall be known as "*The Vaccination and*  
2 *Immunization Act of 2016.*"  
3

4           **Sec. 2. Declaration of Policy.** - The right to health is a fundamental  
5 guarantee enshrined in the Constitution. It is the policy of the State to instill  
6 health consciousness among the people and to protect and promote their right  
7 to accessible and quality health services.  
8

9           Recognizing that vaccinations and immunizations for children have  
10 become expensive and barely accessible for poor families, it is hereby likewise  
11 declared the policy of the State that a comprehensive vaccination and  
12 immunization program is made available to the public for free and its  
13 administration adopted as a program of social justice.

16           **Sec. 3. Components.** - The Department of Health, through all  
17 government hospitals, its satellite offices, accredited government clinics and  
18 other medical institutions, shall provide for free to infants and children  
19 vaccination and immunization services for the following diseases:

- 20           a, Hepatitis B;  
21           b. DPT - diphtheria, tetanus, pertussis (whooping cough);  
22           c. Influenza type B;  
23           d. Polio (Salk injected);  
24           e. Rotavirus (diarrhea and gastroenteritis)

- 1 f. Measles, Mumps, Rubella (German measles);  
2 g. Varicella (chicken pox)  
3

4 Provided, That exemptions may be chosen by the parents on account of  
5 religious belief that prohibits vaccinations and immunizations, or for medical  
6 reasons and which is certified by a licensed medical practitioner, or for any  
7 other valid reason that may be advanced by the parents of the infant or child,  
8 as necessary. Provided, further, that a certain day of the week must be  
9 devoted for immunization and vaccination in all local government unit health  
10 centers.

11  
12 **Sec. 4. Implementing Rules and Regulations.** - The Department of  
13 Health, in consultation with the national association of pediatrics and  
14 recognized experts from the private sector, and non-governmental  
15 organizations and peoples' organizations and academe on child health and  
16 care, shall issue the relevant rules and regulations to implement the  
17 provisions of this Act.  
18

19 **Sec. 5. Fund.** - The amount of One Billión Pesos (P1, 000,000,000.00)  
20 annually to implement the provisions of this Act covering the comprehensive  
21 free immunization and vaccination of children shall be included and  
22 incorporated in the budget of the Department of Health in the General  
23 Appropriations Act. One percent (1%) of all earnings made by government-  
24 owned and controlled corporations shall be collected and form part of the  
25 fund that may be used for this purpose.  
26

27 **Sec. 6. Separability Clause.** - If for any reason, any provision of this  
28 Act is declared invalid or unconstitutional, the remaining provisions not  
29 affected thereby shall continue to be in full force and effect.  
30

31 **Sec. 7. Repealing Clause.** - All executive issuances, rules and  
32 regulations or parts thereof inconsistent with the provisions of this Act are  
33 hereby repealed, amended or modified accordingly.

35 **Sec. 8. Effectivity.** - This Act shall take effect 15 days after its complete  
36 publication in the Official Gazette or in two newspapers of general  
37 circulation.
