#### CALL TO ORDER

At 3:18 p.m., the Senate President, Hon. Aquilino "Koko" Pimentel III, called the session to order.

#### PRAYER

Sen. Paulo Benigno "Bam" Aquino IV stated that on the occasion of the 44th year since then President Ferdinand Marcos signed Proclamation No. 1081, the nation remembers the hundreds of thousands of martial law victims, the atrocities and the institutionalized corruption, and should pray for a peaceful, truthful and just future for the beloved country.

Lead me from death to life, from falsehood to truth. Lead me from despair to hope, from fear to trust. Lead me from hate to love, from war to peace. Let peace fill our heart, our worlds, our universe. Peace, peace, peace.

#### SPONSORSHIP SPEECH OF SENATOR POE

Senator Poe presented to the Body Proposed Senate Resolution No. 105 — Congratulating and Honoring the Filipino Dance Group UPeepz for Winning the 2016 World Hip Hop Dance Championship in Las Vegas, Nevada.

The full text of her speech follows:

The World Hip Hop Dance Championships is the most prestigious hip hop dance contest in the world. It is the Olympics of hip hop.

The UPeepz dance crew bested several dance groups in the Philippines before besting dance groups from 47 countries all over the world. As a result of their hard work and talent, they bagged the gold medal in the Mega Crew division of the World Hip Hop Dance Championship.

At this juncture, Senator Poe presented to the Body the video of the UPeepz's winning dance routine in Las Vegas. Kung meron po tayong pinagmamalaking Pacman hindi lamang sa Las Vegas, Nevada kung hindi sa buong mundo, meron din po tayong UPeepz na nagtagumpay sa Las Vegas.

It is such a delight to be sponsoring something of this nature. First of all, it highlights the achievements of the youth and, of course, my alma mater also, the University of the Philippines. But more importantly, as we focus towards reforms in our country and fighting the battles against illegal drugs, I think it calls to mind also what we need to do which is to empower the youth through education, through support in extracurricular activities. Not just formal education counts, we need to be able to design after-school programs that will encourage the youth to harness their talents.

To be able to come up with the routine that precise, we need discipline, we need camaraderie; we need a unified purpose of winning. I think that this is truly commendable and we can learn from this also; the Senate to work as a body, to achieve a purpose, to succeed.

I would like to take this opportunity to commend Mr. Chips Palma Beltran, the coach, choreographer and prime mover behind UPeepz, and the 74 talented individuals who make up the UPeepz dance crew for your steadfast dedication and commitment to your craft. Please stand to be acknowledged.

You all have brought honor to the country. *Maraming salamat!* The UPeepz should serve as an inspiration to the youth, that skill and talent, if honed, could take you places. They have proven to us that despite the many challenges of our country, there are still some things worth cheering for. Filipinos are creative, talented and expressive. I think that the programs we design for school should not forget the arts and culture.

May I now ask the Body to join me in honoring these outstanding young Filipinos by approving Proposed Senate Resolution No. 105, entitled "A Resolution Congratulating, Commending and Honoring the Filipino Dance Group UPeepz for Bringing Glory and Honor to the Country by Winning the 2016 World Hip Hop Dance Championship." No contribution to this country is too great or small for us not to be able to rejoice together.

#### COSPONSORSHIP SPEECH OF SENATOR VILLANUEVA
