AN ACT AUTHORIZING THE COURT TO REQUIRE COMMUNITY SERVICE IN LIEU OF IMPRISONMENT FOR THE PENALTY OF ARRESTO MENOR, AMENDING FOR THE PURPOSE CHAPTER 5, TITLE 3, BOOK I OF ACT NO. 3815, AS AMENDED, OTHERWISE KNOWN AS "THE REVISED PENAL CODE"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Chapter 5, Title 3, Book I of Act No. 3815, as amended, 1 otherwise known as "The Revised Penal Code", is hereby further amended to 2 include an additional section to read as follows: 3 "ART. 88-A. COMMUNITY SERVICE. - THE COURT MAY, IN LIEU OF SERVICE IN JAIL, REQUIRE THAT THE 5 PENALTY OF ARRESTO MENOR BE SERVED BY THE DEFENDANT 6 BY RENDERING COMMUNITY SERVICE IN THE PLACE WHERE 7 THE CRIME WAS COMMITTED, UNDER SUCH TERMS AS THE 8 COURT SHALL DETERMINE AND UNDER THE SUPERVISION OF 9 THE BARANGAY CAPTAIN OF THE COMMUNITY OR A 10 PROBATION OFFICER. THE DEFENDANT SHALL LIKEWISE BE 11 REQUIRED TO UNDERGO REHABILITATIVE COUNSELING. 12

"IN REOUIRING COMMUNITY SERVICE, THE COURT 1 SHALL CONSIDER THE WELFARE OF THE SOCIETY AND THE 2 REASONABLE PROBABILITY THAT THE PERSON SENTENCED 3 SHALL NOT VIOLATE THE LAW WHILE RENDERING THE 4 5 SERVICE. "COMMUNITY SERVICE SHALL CONSIST OF ANY 6 ACTUAL PHYSICAL ACTIVITY WHICH INCULCATES CIVIC 7 8 CONSCIOUSNESS, AND IS INTENDED **TOWARDS** IMPROVEMENT OF A PUBLIC WORK OR PROMOTION OF A 9 10 PUBLIC SERVICE. "IF THE DEFENDANT VIOLATES THE TERMS OF THE 11 COMMUNITY SERVICE, THE COURT SHALL ORDER HIS 12 REARREST AND THE PENALTY SHALL BE SERVED IN JAIL. 13 HOWEVER, IF THE DEFENDANT HAS FULLY COMPLIED WITH 14 THE TERMS OF THE COMMUNITY SERVICE, THE COURT SHALL 15 ORDER THE RELEASE OF THE DEFENDANT UNLESS DETAINED 16 17 FOR SOME OTHER OFFENSE. "THE PRIVILEGE OF RENDERING COMMUNITY SERVICE 18 IN LIEU OF SERVICE IN JAIL SHALL BE AVAILED OF ONLY 19 20 ONCE." SEC. 2. Implementing Rules and Regulations (IRR). - The Department 21 of Justice and the Department of Social Welfare and Development shall 22 issue the rules and regulations to implement the provisions of this Act within 23 24 ninety (90) days from its effectivity. 25

SEC. 3. Repealing Clause. — Chapter 5, Title 3, Book I of the Revised Penal Code, as amended, is hereby further amended and any law, presidential decree or issuance, executive order, letter of instruction, administrative order, rule or regulation contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly.
