MR. PRESIDENT:

The Committees on Local Government; and Electoral and People's Participation, to which was referred House Bill No. **4938**, introduced by Representative Juliette T. Uy entitled:

"AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY POBLACION 3 IN THE MUNICIPALITY OF VILLANUEVA, PROVINCE OF MISAMIS ORIENTAL"

1. On page 1, delete lines 7-14 and in lieu thereof, insert the ff:

- " Bounded on the Northwest (NW), pts. 1 to 8, by Macajalar Bay;
On the Northeast (NE), pts. 8 to 11, by Brgy. Poblacion I, Case 3;
On the East (E), pts. 11 to 13, by Brgy. Poblacion 2, Case 2;
On the South (S), pts. 13 to 16, by Brgy. Katipunan, Case 13;
On the Southeast (SE), pts. 16 to 18, by Brgy. Katipunan, Case 13;
On the Southeast (SE), pts. 18 to 25, by Brgy. Katipunan, Case 13;
On the Southwest (SW), pts. 25 to 27;

On the West (W) pts. 27 to 1 by Macajalar Bay.

AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY
POBLACION 3 IN THE MUNICIPALITY OF VILLANUEVA,
PROVINCE OF MISAMIS ORIENTAL

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Creation of Barangay Poblacion 3.* — There is hereby
2 created a barangay to be known as Barangay Poblacion 3 comprising of
3 Puroks 1 to 6 of Baybay in the Municipality of Villanueva, Province of
4 Misamis Oriental.

5 SEC. 2. *Territorial Boundaries.* — The territorial boundaries of
6 Barangay Poblacion 3 is hereby described as follows:

1 SEC. 3. *Conduct and Supervision of Plebiscite.* – The plebiscite
2 conducted and supervised by the Commission on Elections (COMELEC)
3 pursuant to Provincial Ordinance No. 914-2006 of the Sangguniang
4 Panlalawigan of the Province of Misamis Oriental, which ratified the creation
5 of Barangay Poblacion 3 as proclaimed by the Plebiscite Board of Canvassers
6 on April 22, 2006, shall serve as substantial compliance with the plebiscite
7 requirement under Section 10 of Republic Act No. 7160, as amended,
8 otherwise known as the “Local Government Code of 1991”.

9 SEC. 4. *Incumbent Barangay Officials.* – The incumbent barangay
10 officials of Barangay Poblacion 3, Municipality of Villanueva, Province of
11 Misamis Oriental shall continue to hold office until such time that their
12 successors have been duly elected and qualified.

13 SEC. 5. *Public Infrastructure and Facilities.* – All public
14 infrastructure and facilities for public use existing therein at the time of the
15 approval of this Act are hereby transferred without cost or compensation to
16 and shall be administered by the new barangay.

17 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay Poblacion 3
18 shall be entitled to Internal Revenue Allotment (IRA) shares pursuant to
19 Section 285 of Republic Act No. 7160, as amended, otherwise known as the
20 “Local Government Code of 1991”.

21 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15) days after
22 its publication in the *Official Gazette* or in a newspaper of general circulation.
