Recommending its approval with amendments.

Sponsor: Senator Angara

**MR. PRESIDENT:**

The Committees on Local Government; and Electoral and People's Participation, to  
which was referred House Bill No. **4935**, introduced by Representative Francisco Jose F.  
Matugas II entitled:

**"AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY DON ALBINO T.  
TARUC IN THE MUNICIPALITY OF SOCORRO, PROVINCE OF SURIGAO DEL NORTE"**

have considered the same and have the honor to report it back to the Senate with the  
recommendation that it be approved with the following amendments:

1. On page 1, line 5, before Sec. 2 (Conduct and Supervision of Plebiscite), insert a  
new section to read as follows:

"SEC. 2. TERRITORIAL BOUNDARIES. – THE TERRITORIAL BOUNDARIES OF BARANGAY  
DON ALBINO T. TARUC SHALL BE IDENTIFIED AS FOLLOWS:

Bounded on the Southwest (SW), Northwest (NW) and Northeast (NE) along  
lines 31-1 to 16 by Barangay Navarro Case 1, Socorro, Surigao del Norte;  
On the East (E) along lines 16 to 31 by the Pacific Ocean.

The Technical Description of Barangay Don Albino T. Taruc is as follows:





AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY  
DON ALBINO T. TARUC IN THE MUNICIPALITY OF SOCORRO,  
PROVINCE OF SURIGAO DEL NORTE

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. *Creation of Barangay Don Albino T. Taruc.* – Puroks I,  
2           II, III and IV are hereby separated from Barangay Navarro and constituted into  
3           a new barangay to be known as Barangay Don Albino T. Taruc in the  
4           Municipality of Socorro, Province of Surigao del Norte.

5           SEC. 2. *Conduct and Supervision of Plebiscite.* – The plebiscite  
6           conducted and supervised by the Commission on Elections (COMELEC)  
7           pursuant to Provincial Ordinance No. 001, Series of 1995 of the Sangguniang  
8           Panlalawigan of the Province of Surigao del Norte, which ratified the creation  
9           of Barangay Don Albino T. Taruc as proclaimed by the Plebiscite Board of  
10          Canvassers on August 27, 1995, shall serve as substantial compliance with the  
11          plebiscite requirement under Section 10 of Republic Act No. 7160, as  
12          amended, otherwise known as the “Local Government Code of 1991”.

13          SEC. 3. *Incumbent Barangay Officials.* – The incumbent barangay  
14          officials of Barangay Don Albino T. Taruc shall continue to hold office until  
15          such time that their successors have been duly elected and qualified.

SEC. 4. *Public Infrastructure and Facilities.* — All public infrastructure and facilities for public use existing therein at the time of the approval of this Act are hereby transferred without cost or compensation to and shall be administered by the new barangay.

5           SEC. 5. *Internal Revenue Allotment Shares.* — Barangay Don Albino  
6 T. Taruc shall be entitled to Internal Revenue Allotment (IRA) shares pursuant  
7 to Section 285 of Republic Act No. 7160, as amended, otherwise known as the  
8 “Local Government Code of 1991”.

9           SEC. 6. *Effectivity.* — This Act shall take effect fifteen (15) days after  
10 its publication in the *Official Gazette* or in a newspaper of general circulation.
