Recommending its approval with amendments.

Sponsor: Senator Angara

MR. PRESIDENT:

The Committees on Local Government; and Electoral Reforms and People's Participation, to which was referred House Bill No. **4925**, introduced by Representative Rodolfo C. Fariñas entitled:

"AN ACT DIVIDING THE ONE-BARANGAY MUNICIPALITY OF DUMALNEG IN THE PROVINCE OF ILOCOS NORTE INTO THREE (3) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY KALAW, BARANGAY CABARITAN AND BARANGAY QUIBEL"

have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

1. On page 1, line 1, delete the words "the One" and hyphen (-) after the word "of".
2. On page 1, line 1, delete the words "Municipality of" after the word "Barangay".
3. On page 1, line 2, delete the words "The One" and hyphen (-) before the word "Barangay".

4. On page 1, line 2, delete the words "Municipality of" after the word "Barangay".
5. On page 2, delete lines 7-9 (Sec. 3. Existing Boundaries) and in lieu thereof, insert the ff:

"SEC. 3. TERRITORIAL BOUNDARIES. – THE TERRITORIAL BOUNDARIES OF EACH BARANGAY CREATED IN THE IMMEDIATELY PRECEDING SECTION SHALL BE IDENTIFIED AS FOLLOWS:

(1) Barangay Kalaw

Bounded on the Southeast (SE), along line 1 to 2, by Municipality of Adams;
 Along line 2-3 by Brgy. Cabaritan;
 On the Southwest (SW), along lines 3 to 5 by Brgy. Cabaritan;
 On the Northwest (NW), along lines 5 to 32 by Brgy. Cabaritan;
 Along lines 32-35 by Quibel; along lines 35-52 by Municipality of Bangui;
 along lines 52-72 by Bolo River;
 On the Northeast (NE), along lines 72-75 by Bolo River; along lines 75-76 by Municipality of Pagudpud; along line 76-1 by Municipality of Adams.

BY REPRESENTATIVE FARÍÑAS, PER COMMITTEE REPORT NO. 79

AN ACT DIVIDING THE ONE-BARANGAY MUNICIPALITY OF DUMALNEG IN THE PROVINCE OF ILOCOS NORTE INTO THREE (3) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY KALAW, BARANGAY CABARITAN AND BARANGAY QUIBEL

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. *Division of the One-Barangay Municipality of Dumalneg.*
2 – The One-Barangay Municipality of Dumalneg in the Province of Ilocos
3 Norte is hereby divided into three (3) distinct and independent barangays to be
4 known as Barangay Kalaw, Barangay Cabaritan and Barangay Quibel.
5 SEC. 2. *Composition.* – The existing puroks and sitios shall comprise
6 the new barangays herein created as follows:
7 (a) Barangay Kalaw. – Barangay Kalaw shall be composed of
8 Purok Crisalita, Purok Saniata, Sitio Pacac, Sitio Banbanag, Sitio Sta. Maria,
9 Sitio Siraong, Sitio As-asaan, Sitio Nasduan, Sitio Nappud, Sitio Nanguratao
10 and Sitio Sisilungen.

1 (b) Barangay Cabaritan. – Barangay Cabaritan shall be composed of
2 Purok Timpuyog, Poblacion, Sitio Alilem, Sitio Cabaritan, Sitio Capcapitan,
3 Sitio Tapauan, Sitio Immalsung and Sitio Mangadamay.

4 (c) Barangay Quibel. – Barangay Quibel shall be composed of Purok
5 Namnama, Purok Danggayan, Purok Regta, Sitio Namoc, Sitio Arapang, Sitio
6 Nalames, Sitio Baracbac, Sitio Bobog and Sitio Baset.

7 SEC. 3. *Existing Boundaries.* – The existing boundaries of the different
8 puroks and sitios enumerated in the immediately preceding section shall be
9 retained and maintained.

10 SEC. 4. *Seat of the Municipal Government.* – The seat of the
11 municipal government shall be at Poblacion, Barangay Cabaritan.

12 SEC. 5. *Conduct and Supervision of Plebiscite.* – The Commission on
13 Elections (COMELEC) shall conduct and supervise the plebiscite to be held in
14 the entire Municipality of Dumalneg, Province of Ilocos Norte within one
15 hundred eighty (180) days from the effectivity of this Act.

16 SEC. 6. *Barangay Officials.* – The first set of officials of the barangays
17 shall be appointed by the provincial governor, in consultation with the
18 Representative of the District, and shall hold office until such time that their
19 successors have been duly elected and qualified.

20 SEC. 7. *Public Infrastructure and Facilities.* – All public infrastructure
21 and facilities for public use existing therein at the time of the approval of
22 this Act are hereby transferred without cost or compensation to and shall be
23 administered by the new barangays.

24 SEC. 8. *Internal Revenue Allotment Shares.* – The Municipality of
25 Dumalneg and all the barangays herein created shall be entitled to Internal
26 Revenue Allotment (IRA) shares pursuant to Section 285 of Republic Act
27 No. 7160, as amended, otherwise known as the “Local Government Code of
28 1991”.

1 SEC. 9. *Effectivity.* — This Act shall take effect fifteen (15) days after
2 its publication in the *Official Gazette* or in a newspaper of general circulation.
