AMENDING SECTION 1 OF PRESIDENTIAL DECREE NO. 1606, AS AMENDED, OR THE LAW CREATING THE SANDIGANBAYAN

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

Section 1. Section 1 of Presidential Decree No. 1606, as amended, is hereby further amended as follows:

"Section 1. Sandiganbayan; composition; qualifications; tenure; removal; and compensation. -- A special court, of the same level as the Court of Appeals and possessing all the inherent powers of a court of justice, to be known as the *Sandiganbayan* is hereby created composed of a Presiding Justice and [fourteen] **TWENTY** Associate Justices who shall be appointed by the President.

9 Section 2. All laws, decrees, orders, regulations and policies inconsistent with
10 the provisions of this Act are hereby repealed and/or amended accordingly.

Section 3. This Act shall have a retroactive effect on 28 July 2014 or the date when Republic Act No. 10660 took effect after its publication in two (2) newspapers of general circulation or in the *Official Gazette*.
