have considered the same and have the honor to report them back to the Senate with the recommendation that S. B. 1712 be approved without amendments, taking into consideration H. B. 6130.



EXPLANATORY NOTE

The State, as mandated by Article II, Section 17 of the 1987 Constitution, prioritizes sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development.

Although we have a number of promising Filipino athletes, a major challenge in nurturing their potentials of becoming world champions is the lack of access to and insufficient, if not the absence of, decent facilities as their ground for training and development.

Research has shown that viable environment and standard sports facilities have a positive correlation not only to an improved performance of the athletes, but also with effective promotion of sports. It is likewise undisputed that such standard sports facilities deter the likelihood of occurrence of injuries.

This bill seeks to expand the Government's support to our athletes on the grassroots, particularly in the Province of Sarangani and other provinces in the SOCCSKARGEN Region, by creating the Sarangani Sports Training Center as a proper and equipped venue in training and molding the athletes in their fullest potentials in sports.

In view of the foregoing, approval of this bill is earnestly sought.



AN ACT
ESTABLISHING THE SARANGANI SPORTS TRAINING CENTER IN THE MUNICIPALITY
OF ALABEL, PROVINCE OF SARANGANI AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 **Section 1.** There shall be established in the municipality of Alabel, Province of Sarangani, a
2 sports training center to be known as the "Sarangani Sports Training Center," which shall be
3 constituted as the primary sports development and training center for the Province of Sarangani.
4
- 5 **Section 2.** The Provincial Government of Sarangani and the Municipal Government of
6 Alabel, in coordination with the Philippine Sports Commission (PSC), shall take the necessary
7 steps to upgrade, improve, and modernize existing facilities, equipment and personnel and
8 integrate them into the newly created sports training center.
9
- 10 The Provincial Government of Sarangani and the Municipal Government of Alabel, in
11 coordination with the PSC, shall create the necessary training programs, appropriate tournaments
12 and competitions, as well as the system by which the facilities shall be maintained and managed
13 in order to accomplish the objectives and purposes of this Act.
14
- 15 **Section 3.** The construction, establishment and operation of the Sarangani Sports
16 Training Center shall be funded by the Provincial Government of Sarangani and the Municipal
17 Government of Alabel, and such funds as may be granted by the PSC and by the Office of the
18 President. In addition, grants and endowments may be obtained from local or foreign sources
19 intended for sports development.
20
- 21 **Section 4.** The Chairman of the PSC shall immediately include in the Commission's
22 program the necessary funding requirements of the Sarangani Sports Training Center.

- 24 **Section 5.** The PSC, in coordination with the Provincial Government of Sarangani, the
25 Municipal Government of Alabel, and other concerned stockholders, shall promulgate the
26 necessary rules and regulations for the implementation of this Act within ninety (90) days after
27 its enactment into law.

Sec. 6. This Act shall take effect fifteen (15) days after its publication in two (2) national newspapers of general circulation. The publication shall not be later than seven (7) days after the approval hereof.

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established in the Municipality of Alabel,
2 Province of Sarangani, a sports training center to be known as the
3 "Sarangani Sports Training Center", which shall be constituted as the primary
4 sports development and training center for the Province of Sarangani.

5 SEC. 2. The Provincial Government of Sarangani and the Municipal
6 Government of Alabel, in coordination with the Philippine Sports Commission
7 (PSC), shall take the necessary steps to upgrade, improve, and modernize
8 existing facilities, equipment and personnel and integrate them into the
9 newly created sports training center.

1 The Provincial Government of Sarangani and the Municipal

3 necessary training programs, appropriate tournaments and competitions,
4 as well as the system by which the facilities shall be maintained and managed
5 in order to accomplish the objectives and purposes of this Act.

18 the implementation of this Act within ninety (90) days after its enactment
19 into law.

20 SEC. 6. This Act shall take effect fifteen (15) days after its publication
21 in the *Official Gazette* or in a newspaper of general circulation.
