



RESOLUTION

CONCURRING IN THE RATIFICATION OF THE AGREEMENT BETWEEN THE GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES AND THE GOVERNMENT OF THE REPUBLIC OF INDONESIA CONCERNING THE DELIMITATION OF THE EXCLUSIVE ECONOMIC ZONE BOUNDARY

WHEREAS, the Constitution, Article 7, Section 21 states: "No treaty or international agreement shall be valid and effective unless concurred in by at least two-thirds of all the members of the Senate";

WHEREAS, the Agreement between the Government of the Republic of the Philippines and the Government of the Republic of Indonesia Concerning the Delimitation of the Exclusive Economic Zone Boundary was signed on 23 May 2014 in Manila, Philippines;

WHEREAS, the Agreement establishes the boundary line that delimits the overlapping exclusive economic zones of the Philippines and Indonesia;

WHEREAS, the Agreement shall not prejudice any rights or positions of the Contracting Parties with regard to the delimitation of the Continental Shelf Boundary;

WHEREAS, the Agreement shall enter into force on the date of the exchange of the instruments of ratification pursuant to Article IV thereof;

WHEREAS, the President of the Philippines ratified the Convention on 15 February 2017 and has accordingly submitted it to the Senate for concurrence, in accordance with the Constitution; and

WHEREAS, in the hearing conducted by the Senate Committee on Foreign Relations on 6 August 2018, the following government agencies endorsed the concurrence to the ratification of the Agreement:

- 1. Department of Foreign Affairs
- 2. Department of Justice
- 3. Department of Environment and Natural Resources
- 4. Department of National Defense

- 5. Armed Forces of the Philippines
- 6. Bureau of Fisheries and Aquatic Resources
- 7. National Mapping and Resource Information Authority

WHEREFORE, BE IT HEREBY RESOLVED, that the Philippine Senate concur, as it hereby concurs, in the Philippine ratification of the Agreement between the Government of the Republic of the Philippines and the Government of the Republic of Indonesia Concerning the Delimitation of the Exclusive Economic Zone Boundary;

RESOLVED, FURTHER, That the rights and well-being of Filipino vessels and fishermen arrested, detained, or meted punitive action for conducting fishing operations in Indonesian or another State's EEZ can be adequately protected; and

RESOLVED, FINALLY, That the Senate President urge the President of the Republic of the Philippines to look into the plight of fishermen currently detained in Indonesia, and to direct the concerned Philippine authorities to pursue the immediate resolution of their cases.

The Honorable Senate President and Members of the Senate Senate of the Philippines Pasay City

Gentlemen and Ladies of the Senate:

I have the honor to submit, for the Senate's consideration, the Agreement between the *Government of the Republic of the Philippines and the Government of the Republic of Indonesia Concerning the Delimitation of the Exclusive Economic Zone Boundary*, which was signed on 23 May 2014 in Manila, Philippines.

The Agreement establishes the boundary line that delimits the overlapping Exclusive Economic Zone of the Philippines and Indonesia.

The Department of Justice, Department of Agriculture, Bureau of Fisheries and Aquatic Resources, Department of Energy, Armed Forces of the Philippines, Department of Environment and Natural Resources, Department of Transportation and Communications (now the Department of Transportation), and the Department of National Defense have been consulted and have concurred with the proposed ratification.

After examining the text thereof, I find it advisable to ratify the Agreement between the Government of the Republic of the Philippines and the Government of the Republic of Indonesia Concerning the Delimitation of the Exclusive Economic Zone Boundary and seek the Senate's concurrence thereto.





AGREEMENT

BETWEEN

THE GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES AND

THE GOVERNMENT OF THE REPUBLIC OF INDONESIA CONCERNING THE DELIMITATION OF THE EXCLUSIVE ECONOMIC ZONE BOUNDARY

The Government of the Republic of the Philippines and the Government of the Republic of Indonesia hereinafter referred to as the "Contracting Parties";

DESIRING to strengthen and enhance the friendly relations between the two countries;

DESIRING further to establish the boundary line that delimits the overlapping Exclusive Economic Zone (EEZ) between the Contracting Parties;

TAKING INTO ACCOUNT the provisions relating to the EEZ boundary delimitation in the United Nations Convention on the Law of the Sea signed at Montego Bay on 10 December 1982 (1982 UNCLOS) to which the Republic of the Philippines and the Republic of Indonesia are State Parties, and the principles of international law applied in the negotiations to achieve an equitable solution;

HAVE AGREED as follows:

Article I

(1) The EEZ boundary between the Contracting Parties is defined by geodetic lines connecting Points 1 to 8 expressed in geographical coordinates based on the World Geodetic System of 1984 (WGS84) Datum, and in the sequence given below:

- The Chart illustrating the EEZ boundary is attached as an Annex to this (2)Agreement.
- This Agreement shall not prejudice any rights or positions of the Contracting (3)Parties with regard to the delimitation of the Continental Shelf boundary.

Article II

The actual location on the sea of the points and geodetic lines referred to in (1)Paragraph (1) of Article I shall be determined by methods to be mutually agreed upon by the competent authorities of the Contracting Parties.

For the purpose of the preceding paragraph, the competent authority of the (2)Republic of the Philippines shall be the National Mapping and Resource Information Authority of the Department of Environment and Natural Resources and the competent authorities of the Republic of Indonesia shall be the Geospatial Information Agency and the Hydro-Oceanographic Office of the Indonesian Navy.

Article III

Any differences in the interpretation, application or implementation of this Agreement shall be resolved amicably by consultation or negotiation, through diplomatic channels.

Article IV

- (1) This Agreement shall be ratified in accordance with the domestic requirements of the Contracting Parties.
- (2) This Agreement shall enter into force on the date of the exchange of the instruments of ratification.

IN WITNESS WHEREOF the undersigned, being duly authorized thereto by their respective Governments, have signed this Agreement.

Done at Manila, Philippines on the Twenty Third day of May in the year Two Thousand and Fourteen in duplicate in English and Indonesian Languages, all texts being equally authentic.

TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE, that whereas, the Agreement between the Government of the Republic of the Philippines and the Government of the Republic of Indonesia Concerning the Delimitation of the Exclusive Economic Zone Boundary was signed on 23 May 2014 in Manila, Philippines; and
