PERIOD OF INTERPELLATIONS ON SENATOR TOLENTINO'S PRIVILEGE SPEECH

(Continuation)

Upon motion of Senator Zubiri, there being no objection, the Body resumed the period of interpellations on Senator Tolentino's privilege speech.

MANIFESTATION OF SENATOR DRILON

Saying that he had thoroughly reviewed the privilege speech of Senator Tolentino as found in the Journal of Session No. 4 dated July 29, 2019, Senator Drilon thanked Senator Tolentino for putting forward a number of novel legal theories, and he admitted that in his almost 50 years of being a lawyer, it was the first time he heard some of them. He said that he was prepared to debate on those propositions that,

to him, have not been settled yet. As he was not claiming to have a monopoly of legal knowledge, he believed that the best avenue to test the validity of those novel propositions would be in a committee hearing rather than in plenary debates, expressing his interest in hearing the thoughts of legal luminaries and recognized experts in international law on these propositions.

Adverting to page 73 of the Journal of July 29, 2019, Senator Drilon pointed out that Senator Tolentino made the statement that "There is no restriction on either the form or substance of international agreements." Following that proposition, he asked: 1) Can the president of the Republic (of the Philippines) enter into an oral or even a written agreement ceding the island of Panay even if it is contrary to Article I of the Constitution? 2) If there is no restriction as to form, can multilateral agreements be in the form of an oral agreement? He said that he could not imagine the confusion and difficulty of enforcing a verbal multilateral agreement.

To Senator Tolentino's forceful assertion that matters of foreign policy are within the exclusive and absolute power of the president, citing as an authority the case of *Saguisag vs. Ochoa* (G.R. No. 212426, January 12, 2016), Senator Drilon noted that in the *Saguisag* case, the Supreme Court specifically stated that the role of the president in foreign affairs is qualified by the Constitution, giving particular importance to the sovereignty of the nation and the integrity of its territory; it does not crystalize into an absolute discretion to craft whatever instrument the chief executive so desires. In fact, he pointed out that this power is limited by a number of constitutional provisions, including Sections 20 and 21 of Article VII, Sections 4(2) and 5(2)(a) of Article VIII, and Sections 4 and 25 of Article XVIII.

Senator Drilon congratulated Senator Tolentino for putting forward those novel theories and for single-handedly opening up the discussion on complicated issues surrounding the West Philippine Sea. He said that he would look forward to the inquiry that would be conducted by the Committee on Foreign Relations which was made possible by Senator Tolentino's early and timely manifestation. He said that he would not further occupy the Senate's time in a very complicated legal debate which would only be appreciated by lawyers, and he believed that such a legal debate should be done by the legal experts in the committee. He added that he would

await the committee report so that he could thoroughly discuss and respond to these legal theories.

Thus, Senator Drilon manifested that he no longer has any questions for Senator Tolentino.

REJOINDER OF SENATOR TOLENTINO

Senator Tolentino clarified that the basis of his proposition is that the President is considered as the chief architect of the country's foreign policy acting on constitutional grounds, and that oral agreements are done on a bilateral basis. As to the reference to the Philippine Constitution, he said that the case cited is apropos to the Constitutional Commission deliberation as it affirmed that in the hierarchy of foreign policy, the chief executive is first, and that the role of the Senate is only limited to concurrence unlike that of the United States Senate which is limited to advice and consent. Nevertheless, he deferred to Senator Drilon's manifestation that the speech be referred to the Committee on Foreign Relations and even to the Committee on Constitutional Amendments and Revision of Codes as the secondary committee.

MANIFESTATION OF SENATOR GORDON

At the outset, Senator Gordon commended Senators Tolentino and Drilon for enriching the discussion on vital issues faced by the country, as he took note of the recent statement of the Secretary of National Defense that China was being a bully. He said that it was disturbing that China as the country's biggest neighbor, with a powerful military air force, navy and army, has militia on board all their sea-going crafts, including fishing boats. He noted that even Vietnam, which also has militia on board their aircraft, is able to track down the traffic going on in the West Philippine Sea and the South China Sea. He suggested that the Philippines should consider following their examples in light of the recent incident when the Liaoning, an aircraft carrier of China, passed through the Sibu Strait. He believed that the local fishermen should be equipped with GPS and communications facilities so that the authorities would be quickly alerted about traffic, threat or mining activities on the ocean.

Thus, Senator Gordon said that the speech of Senator Tolentino was very timely as it would afford the Senate the opportunity to discuss the issue in an

objective way because democracy subsists well when opinions are expressed through intelligent debates. He hoped that the the hearing would pave the way for discussions on the military strength of the countries involved in the contested areas. This way, he said that the Philippines would be better prepared and even increase the capabilities of the army, navy and coast guards.

In closing, Senator Gordon stated that it is important for their ideas to reflect history so that the country can move forward and see what lies ahead.

REFERRAL OF SPEECH TO COMMITTEE

Thereupon, Senator Zubiri moved that the privilege speech of Senator Tolentino, together with the interpellations and manifestations thereon, be referred to the Committee on Foreign Relations as the primary committee, and to the Committee on Agriculture and Food as the secondary committee.

Senator Drilon asked for the reconsideration of the secondary committee referral as he pointed out that the issue of fisheries, as mentioned in the speech, was simply incidental to the main issue of sovereignty, sovereign rights, and others. He maintained that the Committee on Agriculture and Food deals with the substantial aspects of fisheries as an economic activity. Senator Zubiri explained that the speech also dealt with the issues on the country's lack of fishing grounds and the fisheries resources. He noted that the primary committee referral was still with the Committee on Foreign Relations under Senator Pimentel.

Senate President Sotto suggested that the speech be referred only to the Committee on Foreign Relations as the issue involved foreign policy. If necessary, he said that the issue on fisheries can be taken up by the Committee on Agriculture and Food later on.

Agreeing with Senate President Sotto, Senator Drilon opined that the principal issue and the basic proposition of the speech was on foreign policy over which the Committee on Agriculture and Food, as stated in the Rules, does not have jurisdiction.

Senator Zubiri said that he would defer to the wishes of the Body, as long as the issue would be taken up by a proper committee and be discussed and debated there.

Upon motion of Senator Zubiri, there being no objection, the Chair referred Senator Tolentino's privilege speech and the interpellations thereon to the Committee on Foreign Relations.

ADDITIONAL COMMITTEE REFERRAL

Acting on the request of Senator Tolentino, Senator Zubiri moved that Senate Bill No. 201, the bill postponing the May 2020 Barangay and *Sangguniang Kabataan* elections, be referred secondarily to the Committee on Local Government.

Senator Drilon pointed out that this was not the first time that such measure was considered in the Senate as they also took up similar measures postponing the barangay elections in the past. He asked to which committee those similar measures were referred. Senator Zubiri informed the Body that in the Seventeenth Congress, the bill on the first postponement of the barangay elections was handled by the Committee on Local Government, while the second postponement was referred to the Committee on Electoral Reforms and People's Participation because at that time, Senator Angara, the chairman of the Committee on Local Government, was busy with the TRAIN bill.

Senator Zubiri stated that in consultation with Senators Tolentino and Marcos, chairpersons of the Committee on Local Government and the Committee on Electoral Reforms and People's Participation, respectively, they agreed that the primary committee would be the Committee on Electoral Reforms and People's Participation.

At this juncture, Senator Angara clarified that there was nothing unusual with the manifestation of Senator Zubiri as he recalled that in the previous Congress, he asked Senator Gordon to handle the measure postponing the barangay and SK elections the second time as he had on his plate then both the TRAIN bill and the proposed Bangsamoro Organic law.

Senator Tolentino explained that he requested the referral of the bill to the Committee on Local Government because most of the SK and barangay elections were partly funded by the LGUs and that there has never been an instance wherein the Comelec fully funded such elections.

Upon motion of Senator Zubiri, there being no objection, the Chair also referred Senate Bill No. 201 to the Committee on Local Government as the secondary committee.

COMMITTEE REPORT NO. 1 ON PROPOSED SENATE RESOLUTION NO. 52

Upon motion of Senator Zubiri, there being no objection, the Body considered Proposed Senate Resolution No. 52 (Committee Report No. 1), entitled

RESOLUTION AMENDING SECTION 13 (4), (22), (28), (29), AND (34), RULE X OF THE RULES OF THE SENATE.

Pursuant to Section 67, Rule XXIII of the Rules of the Senate, with the permission of the Body, upon motion of Senator Zubiri, only the title of the resolution was read without prejudice to the insertion of its full text into the Record of the Senate.

The Chair recognized Senator Zubiri for the sponsorship.

SPONSORSHIP SPEECH OF SENATOR ZUBIRI

Senator Zubiri presented to the Body Proposed

Senate Resolution No. 52, which seeks to amend Section 13, Rule X of the Senate Rules.

The full text of Senator Zubiri's sponsorship speech follows:

The Committee on Rules met last Monday, July 29, a well-attended one with eight out of nine members present.

In that meeting, the Committee discussed several proposed Senate resolutions amending Section 13 of the Rules. These are the proposed resolutions creating a new standing committee to be known as the Committee on Overseas Filipinos (PSR No. 5); splitting the Committee on Education into two - the Committee on Basic Education, Arts and Culture and the Committee on Higher, Technical, and Vocational Education (PSR No. 24); and the resolution on the creation of the Committee on Sustainable Development Goals, Innovation and Futures Thinking (PSR No. 44).

We also received requests from several committee chairpersons to increase the number of the memberships in their respective committees.

On the creation and splitting of the committees, the Committee decided to resolve first the splitting of the Committee on Education into two. These are the Committee on Basic Education, Arts, and Culture, and the Committee on Higher, Technical, and Vocational Education. Among the reasons cited for this is that the jurisdiction of the Committee on Education is too broad, and basically, education is divided into two main concerns or subsectors — the basic and higher education. Also, this is to align our Committee on Education with the House of Representatives, which has the Committee on Education and Committee on Higher Education.

As to the requests of several committee chairpersons to increase the number of membership in their respective committees, such as the Committee on Finance, Committee on Tourism, Committee on Public Services, and Committee on Public Information, the Committee has decided to authorize this Representation as chair of the Committee on Rules to act on these requests as he sees fit and meritorious.

And so, we propose to amend the specific paragraphs of Section 13 pertaining to the number of membership of the aforementioned committees. For instance, the Committee on Finance is so important to our work as legislators as the General Appropriations Act (GAA) is

among the most significant pieces of legislation that we pass every year, and as the GAA mirrors the implementation of the policies and priorities laid out by the Legislative and Executive branches of government through concrete programs and projects.

Thus, we propose that all members of the Senate be members of the Committee on Finance, including the Senate President Pro Tempore, the Majority Leader, and the Minority Leader who are already *ex officio* members of all the standing committees as per Section 20 of the Rules.

On the other hand, we propose a considerable increase of memberships in the Committees on Tourism, Public Services, and Public Information and Mass Media.

On the proposal to create new standing committees, the Committee decided to further discuss these proposals in the next hearing of the Rules Committee.

Relative to this, the Committee also directed the Secretariat to prepare a matrix on the bills and resolutions referred to the committees in the 17th Congress and to study the jurisdiction and names of our standing committees to avoid overlapping jurisdictions and for a possible merger and streamlining of committees with similar jurisdictions. This was actually the humble suggestion of our distinguished Minority Leader — to study which committees had the least referrals and the most referrals, and maybe we could streamline the number of committees with this study.

With that, we propose to amend Section 13, Rule X of the Senate Rules as reflected in our Committee Report.

MANIFESTATION OF SENATOR GORDON

For the record, Senator Gordon registered his support for Proposed Senate Resolution No. 52 as he was unable to affix his signature thereon when it was circulated that morning.

REQUEST OF SENATOR DRILON

At this juncture, Senator Drilon requested that Senator Zubiri and the technical staff review the number of standing committees the Senate has at present, noting that during the hearing of the Committee on Rules, it was reported that there were already 40 committees, just too many for 22 senators to handle — the Senate President and the Minority Leader do not have any committee — and could put pressure on the administrative staff. He then asked

for a review of the referrals to committees in the 17th and 18th Congresses and find out which committees are active and inactive in order to identify which committees must be retained and correspondingly rationalize the organization of standing committees in the Senate by adjusting their jurisdiction.

Senator Gordon expressed his support to the proposal of Senator Drilon, further suggesting the merging of some, given the large number of standing committees.

Senator Zubiri informed the Body that the matter would be discussed in the meeting with the Secretariat on Wednesday the following week.

ADOPTION OF PROPOSED SENATE RESOLUTION NO. 52

Upon motion of Senator Zubiri, there being no objection, the Body adopted Proposed Senate Resolution No. 52.

MANIFESTATION OF SENATOR ZUBIRI

Pursuant to the resolution, Senator Zubiri directed the Secretariat to review all the referrals of bills made in the last two weeks, particularly those referred to the Committee on Education, Arts and Culture, so that the proper change of referrals would be made.

Senate President Sotto said that since the Secretariat has just received the communication, they may submit a report thereon to the Senate on Monday.

MANIFESTATION OF SENATOR DRILON

Senator Drilon reiterated his request that notices of committee hearing must comply with the three-day notice as stipulated in the *Rules*.

For his part, Senate President Sotto called on the chairpersons of the different committees to ask their respective chiefs of staff to always coordinate with the committee secretary in the preparation of the committee reports considering that in the past, some committee reports that were forwarded to the Bills and Index Service had not even been seen by the committee secretary concerned resulting in errors that had to be corrected on the floor. He underscored the importance of ensuring that the committee secretaries are well-informed of the reports that are prepared by the chiefs of staff of the different senators.

Relative thereto, Senator Drilon stated that in the past Congresses, they had a very good arrangement crafted not by the rules but out of courtesy. He cited the practice of not allowing committee reports to be filed unless they had passed through the Minority Leader's office. He believed that elementary courtesy dictates that the Minority Leader must see the report before it is filed, adding that he never caused any delay as regards the filing of committee reports.

Senate President Sotto expressed confidence that both the Senator Zubiri and Senator Drilon would continue such working arrangement.

Senator Zubiri gave assurance that all committee reports would pass through the office of Senator

Drilon before these are filed, and he instructed the Secretariat to ensure that before a committee report reaches his office, it has visited the office of the Minority Leader for study.

Senate President Sotto also reminded the chiefs of staff of all senators to allow the committee secretary to review the committee reports before these are submitted to the Office of the Senate President.

ADJOURNMENT OF SESSION

Upon motion of Senator Zubiri, there being no objection, the Chair declared the session adjourned until three o'clock in the afternoon of Monday, August 5, 2019.
