taking into consideration Senate Bill No. 1229, introduced by Senator Angara, entitled:







AN ACT DECLARING NOVEMBER 8 OF EVERY YEAR A SPECIAL
NONWORKING PUBLIC HOLIDAY IN THE EASTERN
VISAYAS REGION TO BE KNOWN AS THE "YOLANDA
COMMEMORATION DAY"

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. November 8 of every year is hereby declared a
2 special nonworking holiday in the highly urbanized City of Tacloban
3 and the provinces of Leyte, Biliran, Southern Leyte, Northern
4 Samar, Samar, and Eastern Samar to honor the memory of all who
5 perished during the onslaught of Typhoon Yolanda (Haiyan) on
6 November 8, 2013, and to salute the selflessness of all volunteers
7 and organizations that took part and contributed in the recovery
8 and rehabilitation efforts of the communities affected by the
9 typhoon.

1 SEC. 2. This Act shall take effect fifteen (15) days after its
2 publication in the *Official Gazette* or in a newspaper of general
3 circulation.
