SPONSORSHIP SPEECH OF SENATOR MARCOS

Senator Marcos, as chairperson of the Committee on Electoral Reforms and People's Participation, submitted for the plenary consideration of the Body Senate Bill No. 1174 under Committee Report No. 22, otherwise known as the "Abolishing the Printing of the Voters Information and Instruction Sheet."

Following is the full text of Senator Marcos' sponsorship speech:

Almost 35 years ago, Republic Act No. 7904 amended the Omnibus Election Code to enjoin the Comelec to furnish every registered voter through registered mail with return card, personal service with corresponding receipt to be signed by the voter or any person who knows the voter, or any other practical means, with an unfilled official sample ballot, voter information sheet, and the list of all registered national, provincial,

and city candidates to be voted for in the said election.

While we today derive most of our news digitally, remaining online and interactive in real time through all our waking hours, and our children look forward to a future filled with the internet of things, Artificial Intelligence (AI) or artificial-aided near future, our Comelec is condemned by an antiquated law to reach each one of over 61,000,000 voters by mail—old unreliable regular snail mail.

Not only is this a major dent in our country's financers but an unconscionable waste of time, energy, and focus for each one of our election officers.

Today, I submit Committee Report No. 22 sponsoring therewith Senate Bill No. 1174, entitled "An Act Amending Section 185 of the Omnibus Election Code, As Amended, Abolishing the Printing of the Voters Information and Instruction Sheet," so that finally, together with the rest of the world, we enter the information age doing away with the mandatory printing and posting by mail of the said unfilled official sample ballot, voter information, and the list of registered national, provincial, and city candidates.

The elections last year are just the most recent example of the absurdity of the Comelec voter's information mandate. Despite spending P294,000,000 plus in 2019 for the printing of voter's information and instruction sheet, an additional P67,000,000 plus for the deployment and distribution of the same, such voter's information and instruction sheet resulted in so many mistakes in the 18,000 plus available positions up for voting with so many mistakes in the names and numbers of the numerous candidates that the Comelec had to issue Minute Resolution No. 190546 dated May 9, 2019, finally surrendering, giving up, and ordering that the manual correction of said voter's information and instruction sheets by the local election officer should please be done before distribution. Obviously, this was never actually implemented for lack of material time.

In fact, in far-flung areas of the archipelago such as Zamboanga del Sur, Zamboanga del Norte, Zamboanga City, not a single voter's information and instruction sheet was mailed or received by even a single voter. Meanwhile, in Zamboanga Sibugay, only five of 16 municipalities mailed the voter's information to their respective voters.

In exasperation, the Comelec urged us during a public hearing in the Committee on Electoral

Reforms and People's Participation last October 8, 2019, recommending that we should finally do away entirely with the mailing of hard copies to individual voters and merely retain the posting of Voter's Information and Instruction Sheets at the barangay and precinct levels.

The proposed bill, therefore, is a simple and budget-saving solution, updating the Comelec requisite of informing the public by publication through broadcast, digital or electronic media, in addition to displaying the same information at conspicuous public areas including barangay halls. No regular or individual snail mail letters rife with errors and confusion with missing positions and misspelled names shall henceforth be utilized.

We cannot stand in the way of progress. Instead, let us harness technology to push our democracy and every single one of our electoral processes to the forefront of this digital information age. It is in the nature of the landscape to change, and it is in the nature of people to help that process along.

Today, I enjoin you all in our Chamber to help the process of electoral modernization along.

OMNIBUS SPONSORSHIP SPEECH OF SENATOR TOLENTINO

With the permission of the Body, Senator Tolentino delivered his omnibus sponsorship speech on House Bill Nos. 5028 and 4960 under Committee Report Nos. 40 and 41, respectively.

The full text of Senator Tolentino's sponsorship speech follows:

This humble representation rises to sponsor two local holiday bills. Specifically, we are sponsoring:

- Committee Report No. 40 on House Bill No. 5028, entitled, "An Act Declaring February 24 of every year a Special Nonworking Public Holiday in the Province of Zamboanga Sibugay in Commemoration of its Founding Anniversary To Be Known As 'Araw Ng Sibugay," which the committee, with the approval of the proponents, deemed better to rename as "Araw ng Zamboanga Sibugay;"
- 2) Committee Report No. 41 on House Bill No. 4960, "An Act Declar-ing November 8 of Every Year a Special Non-working Public Holiday in the Eastern Visayas Region to be Known as 'Yolanda Commemoration Day'."

Upon perusal of the records of the previous Congress, the Committee found it appropriate to

adopt the same criteria used by the last Congress in declaring nonworking holidays, to wit: 1) It is the founding anniversary of charter day of the LGU concerned; 2) It involves honoring a hero revered in the locality; 3) It involves commemoration of an event with historical or cultural importance subject to the favorable indorsement of the National Historical Commission of the Philippines; and 4) The number of existing legislated nonworking holidays in the locality does not exceed two.

For the holiday of "Araw ng Zamboanga Sibugay," this meets criteria No. 1. As I mentioned, this is the province's charter day. The Province of Zamboanga Sibugay was formerly part of the Province of Zamboanga del Sur until the new province was finally separated and created by Republic Act No. 8973, signed on November 7, 2000, and ratified through a plebiscite on February 24, 2001, the very day this bill seeks to declare as a holiday.

Likewise, this passes criteria No. 4 as, currently, there is no single nonworking holiday in the province.

Zamboanga Sibugay is composed of 16 municipalities and 389 barangays which serves as the home of approximately 630,000 Filipinos who are looking forward to celebrate their colorful history and showcase their distinct identity on the day, the founding day, the very birthday of the province they hold dear.

For the second holiday of the *Yolanda* Commemoration Day, this arguably meets criteria No. 3, for Filipinos do not need any certification from anybody to remind us of the significance and impact of typhoon *Haiyan*, or typhoon *Yolanda*, had in our lives six years ago. However, the monstrous typhoon *Yolanda*, known as *Haiyan*, a category 5 mega cyclone, with terrifying speeds of 150 to 180 miles per hour, left nothing but destruction on its path and devastated in its wake particularly the Visayan region. To date, the name sends a grim reminder of the events caused by the disaster.

In fact, the name *Yolanda* was stricken off the list of probable typhoons by the weather bureau.

Thousands died, thousands missing, death probably running up to more than 6,000 civilians and more, billions of pesos worth of damages in infrastructure, violence in the aftermath, and a grieving nation despite the proximity of the holidays, because that was already November.

The act of commemorating the deluge of *Yolanda* is to pay respects to the lives that have

been lost, to remember the bravery and heroism of those who risked their lives to rescue and provide relief to the victims, and also as a salute to the bravery, courage, and resilience of the survivors and the families left behind.

For these reasons, I urge my colleagues to pass these measures.

Senator Zubiri stated that the parliamentary status was the period of individual amendments.

Thereupon, the Chair recognized Senator Pimentel, sponsor of the measure.

 - A) BAMBOO REFERS TO A NON-TIMBER FOREST **PRODUCT** CLASSIFIED AS GRASS, WHICH USUALY HAS HOLLOW CULMS AND LIGNOSECELLULOSE MATRIX, THAT IS USED AS TIMBER SUBSTI-TUTE AND AS RAW MATERIAL FOR BAMBOO-BASED PRODUCTS. INCLUDING BUT NOT LIMITED TO PULP AND PAPER, TEXTILES, HOUSE CONSTRUCTION MATERIALS, COAL, CUTLERIES, COSMETICS, DENTAL CARE, AND FOOD;
- Replace lines 8 to 12 with the following subparagraph:
 - C) BAMBOO INDUSTRY THE INDUSTRY ASSOCIATED WITH THE PLANTING AND CULTIVATION OF BAMBOO AND BAMBOO-BASED PRODUCTS, INCLUDING BUT NOT LIMITED TO HANDICRAFTS, BAMBOO SHOOTS, BAMBOO UTILIZED FOR CONSTRUC-TION PURPOSES, BAMBOO FOR INDUSTRIAL PRODUCTION INVOLV-ING MECHANIZED PROCESSING OF LARGER VOLUMES OF CULMS, SUCH AS FOR FLOORING, LAMINATED FURNITURES, CHOPSTICKS, MAT BOARDS, CHARCOAL, PAPER AND PULP, TEXTILES, AND UNPROCESSED BAMBOO CULMS UTILIZED IN APPLICATIONS, SUCH AS SCAF-FOLDING AND TRADITIONAL CONSTRUCTION:
- 4. On line 20, after the word "including," insert the phrase BUT NOT LIMITED TO;
- On the same line, after the word "handicraft" and the comma (,), insert TEXTILES;

- On line 6, after the word "building" and the comma (,) insert the phrase QUALITY ASSURANCE, TESTING;
- 7. On line 29, between the figure "879" and then comma (,), insert the figure S. 2010;

- On line 19, after the word "industry," insert the phrase AS BAMBOO PROCESSOR OR BAMBOO PRODUCT MANUFAC-TURER;
- 13. Reletter the subparagraphs accordingly;

- On line 9, after the word "formulate," insert a comma (,) and the phrase UPDATE AND PUBLISH;
- 15. Replace the words, starting with the word "The" on line 23 up to the word "regulations" on line 30, with the following paragraph:

THE STAFF AND PERSONNEL OF THE SECRETARIAT SHALL COME FROM THE EXISTING PERSONNEL OF THE DTI. HOWEVER, SHOULD THERE BE NO AVAILABLE AND QUALIFIED PERSONNEL, THE DTI SECRETARY MAY PROPOSE THE CREATION OF NEW POSITIONS TO ACCOMMODATE THE NEEDS OF THE CENTER. FOR THIS PURPOSE, THE SECRETARY MAY ALSO CREATE THE ORGANIZATIONAL STRUCTURE, STAFFING PATTERN AND COMPENSATION SCHEDULE IN ACCORDANCE WITH THE CIVIL SERVICE COMMISSION (CSC).

- On line 30, replace the word "shall" with MAY:
- 17. On line 31, replace the word "by" with OF;

- 19. On line 7, after the acronym DENR, insert a comma (,) and delete the word "and"; after the acronym DOST-FPRDI, insert a comma (,) and the phrase DOST-PCAARRD, DOST-PTRI, DTI, AND THE DA;

- 20. On line 26, after the word "activities," insert the phrase AND CAPABILITY TRAININGS;

PROPOSED AMENDMENT OF SENATOR PIMENTEL

Still on page 7, line 27, after the word "bamboo" and the period (.), Senator Pimentel proposed to insert a new sentence, to read as follows:

THE DENR SHALL LIKEWISE ALLOT NOT LESS THAN 25% OF THE BUDGET FOR THE EXPANDED NATIONAL GREENING PROGRAM UNDER EXECUTIVE ORDER NO. 193, S. 2015, TO BAMBOO PLANTATION AND PROPAGATION.

At this juncture, Senator Drilon asked how much would be the equivalent of 25% of the budget for the Expanded National Greening Program. Senator Pimentel replied that it is P1 billion, which is 25% of the total Expanded National Greening Program budget of P4 billion.

Since it was expressed in percentage, Senator Drilon asked if the amount would correspondingly increase since the budget of the Expanded National Greening Program is increased yearly. Senator Pimentel answered in the affirmative.

Asked how the figure 25% was arrived at, Senator Pimentel replied that it was based on Executive Order No. 193.

But Senator Drilon pointed out that EO 193 referred only to the National Greening Program, and that it did not mention 25%. He said that the way the proposed amendment was phrased, a substantial allotment of P1 billion was being earmarked only for bamboo without any explanation and rationalization for such earmarking.

Senator Villar explained that the intent of the proposal is to institutionalize, through the law, the executive order that provides that 25% of the greening program should be planted with bamboo. She added that another executive order also mandated the DepEd "to buy 25% of their chairs made of bamboo."

Senator Drilon pointed out that the reference used was merely an executive order and that nothing

therein earmarked 25% for bamboo plantation. He noted that the executive order actually allocates 25% of the area and not of the budget.

Senate President Sotto stated that the question of Senator Drilon was how the figure 25% was arrived at.

Senator Pimentel acknowledged that Senator Drilon was correct that the executive order did not mention an amount. He expressed willingness to accept any proposed amendment by Senator Drilon as regards the percentage to be allocated to the bamboo industry.

However, Senator Drilon stated that the proposal was completely a new provision which was never discussed on the floor because it was not found in the original committee report. He said that he was not prepared to bargain because to him, that would be arbitrary. He said that he was willing to support the P1 billion proposal but that he would like to know how the P1 billion was arrived at.

Senator Lacson recalled that during the deliberation on the DENR budget, in response to Secretary Cimatu's request for some amount for the bamboo industry, there was an agreement that P1 billion would be taken out of the National Greening Program which, however, did not materialize and the P1 billion remained with the National Greening Program. He confirmed Senator Drilon's assertion that there was nothing in the executive order that 25% or P1 billion should be appropriated or allocated to the bamboo industry. He added that there was no law yet to the effect.

Senator Pimentel stated that precisely, the bill was proposing that the law mandates that 25% of the budget of the National Greening Program would go to the bamboo industry. He said that the proposal was purely a policy issue which could still be adjusted.

Senator Drilon disagreed, saying that it was a question of appropriating P1 billion. He believed that there was a basis for him to ask how the amount of P1 billion was arrived at.

Senator Villar explained that in her experience in the department, if Congress does not indicate the amount to be allocated, the department would not implement it; thus, if Congress wants to help the bamboo industry, it has to indicate in the law how

much it would allocate. She reminded Senator Drilon that Iloilo is the bamboo capital of the Philippines and that they have the best bamboo plantation in the Philippines located in Maasin, Iloilo.

Senator Drilon asked Senator Villar to stop alluding to personal motives. He said that even if Iloilo does not get a single peso, he could support any amount as long as there is justification for it.

To clarify, Senate President Sotto said that Senator Drilon wanted to know how the figure was arrived at and suggested that the proposal be discussed further since it was not taken up during the period of interpellations.

SUSPENSION OF SESSION

Upon motion of Senator Zubiri, the session was suspended.

It was 5:40 p.m.

RESUMPTION OF SESSION

At 5:53 p.m., the session was resumed.

MANIFESTATION OF SENATE PRESIDENT SOTTO

Senate President Sotto stated that before the suspension, there was an issue raised on page 7 of the measure, and to resolve the problem, there was an agreement that the amendment would indicate a percentage of the greening area without having to

place or earmark an amount or budget; however, given its implications on the other parts of the bill, Senator Drilon suggested that the executive order be incorporated so that it would no longer be touched later on.

At this juncture, Senator Pimentel requested to suspend the period of amendments until the next session day.

SUSPENSION OF CONSIDERATION OF SENATE BILL NO. 1240

Upon motion of Senator Zubiri, there being no objection, the Body suspended consideration of the bill.

ADJOURNMENT OF SESSION

Upon motion of Senator Zubiri, there being no objection, the Chair declared the session adjourned until three o'clock in the afternoon of the following day.
