RESOLUTION

COMMENDING DR. RAUL DESTURA AND HIS COLLEAGUES FOR THEIR INVALUABLE CONTRIBUTION TO PUBLIC HEALTH THROUGH THEIR INVENTION OF RELIABLE, FAST, AND AFFORDABLE CORONAVIRUS DISEASE (COVID-19) TEST KITS

1	Whereas, Coronavirus disease (COVID-19) is described by the World Health
2	Organization (WHO) as a new strain of Coronaviruses that "cause illness ranging
3	from the common cold to more severe diseases";
4	Whereas, COVID-19 was first reported on 31 December 2019 in Wuhan,
5	China as a pneumonia of unknown cause and has not been previously identified in
6	humans;
7	Whereas, COVID-19 outbreak was declared by WHO as a Public Health
8	Emergency of International Concern on 30 January 2020;
9	Whereas, with the significant spread and severity of COVID-19 cases
10	coupled with "alarming levels of inaction", WHO characterized the outbreak as
11	pandemic on 11 March 2020;
12	Whereas, in the 135 countries, areas or territories around the world,
13	including the Philippines, that has been affected by COVID-19, there are 142,649
14	confirmed cases of the disease and 5,393 deaths recorded by WHO as of 14 March
15	2020;
16	Whereas, in the Philippines, the Department of Health (DOH) activated on
17	13 March 2020 Code Red Level 2, the highest level of national response
18	management because of the "growing threat of COVID-19 health emergency";

Whereas, the Laboratory Status of Patients of the Department of Health
 (DOH) as of 12:00nn of 15 March 2020 recorded 140 confirmed cases, while 638
 cases tested were negative and 72 cases are still awaiting test results;

4 **Whereas**, for persons who were exposed to the virus or who are 5 experiencing its symptoms, early detection of the disease is very important not only 6 to appropriately address the needs of the patient but also to protect the people 7 around them, including the health care professionals who are attending to them;

8 **Whereas**, in general, such early detection will be very helpful in mitigating 9 the spread of the virus among the populace, especially the vulnerable members of 10 the community;

11 **Whereas**, the COVID-19 test kit is the only tool that can confirm if a person 12 has acquired the disease;

Whereas, the test kits are manufactured in other countries, which, in a list of
 the World Health Organization as of 06 March 2020 included China, Germany, Hong
 Kong, Japan, Thailand, US, and France;

Whereas, apart from the fact that there is no local producer of COVID-19 test kits in our country, the representative from the Research Institute for Tropical Medicine (RITM) stated in a public hearing conducted by the Senate Committee on Economic Affairs that there are only 2,000 test kits available in the country that were from WHO and Japan;

Whereas, late detection leads not only to deaths of the patients but also lack of proper precaution and preparedness of the people, especially of those surrounding the patient, thus posing great threat to their health;

Whereas, the low capacity to conduct test is also a challenge as accounted by a news article that at that time, DOH estimates the demand for COVID-19 testing at 600 to 700 per day but RITM can conduct only 300 per day because a patient will have to undergo tests at least three (3) times and aside from the confirmatory test, a confirmed patient must be tested twice before being discharged from the hospital;

29 **Whereas**, the government declared that there are enough funds to purchase 30 test kits but there is a global shortage in the supply of the same;

7 **Whereas**, their invention is indeed a valuable contribution to the public 8 health of the country and the expertise, efforts, and hard work of Dr. Destura and 9 his colleagues deserve all the respect, gratitude and commendation of the entire 10 nation;

11 NOW THEREFORE, BE IT RESOLVED BY THE SENATE, AS IT IS 12 HEREBY RESOLVED, To commend Dr. Raul Destura and his colleagues for their 13 invaluable contribution to public health through their invention of reliable, fast, and 14 affordable Coronavirus Disease (COVID-19) Test Kits.
