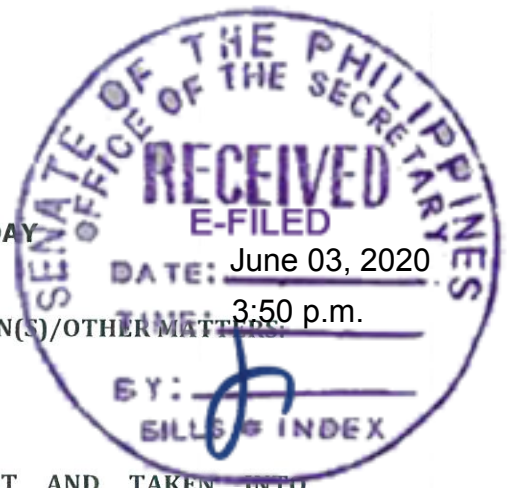

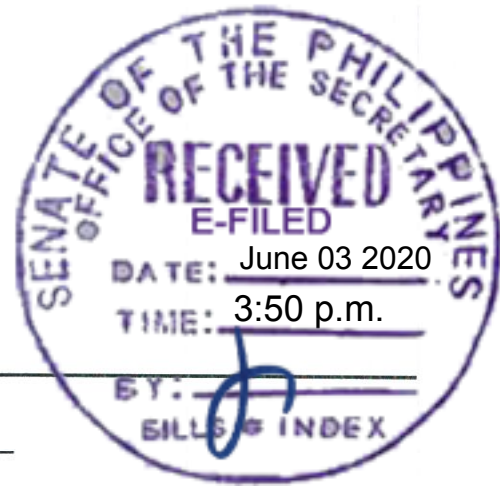


The Committee on Local Government, to which was referred **House Bill No. 5692**, introduced by Representative Aurelio "Dong" D. Gonzales, entitled,

TO BE KNOWN AS THE "MT. PINATUBO MEMORIAL DAY"

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. June 15 of every year is hereby declared a special
2 nonworking holiday in the Province of Pampanga to commemorate
3 the eruption of Mt. Pinatubo.

4 SEC. 2. This Act shall take effect fifteen (15) days after its
5 publication in the *Official Gazette* or in a newspaper of general
6 circulation.




