Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1	SECTION 1. Section 1 of Republic Act No. 10775 is hereby									
2	amended to read as follows:									
3	"SECTION 1. June 21 of every year is hereby									
4	declared a special NONworking holiday [and no									
5	class day in schools] in Tagaytay City, Province of
