AN ACT INCREASING THE BED CAPACITY OF THE MAYOR HILARION A. RAMIRO SR. MEDICAL CENTER IN THE PROVINCE OF MISAMIS OCCIDENTAL FROM FIVE HUNDRED (500) TO ONE THOUSAND (1,000) BEDS, UPGRADING ITS PROFESSIONAL HEALTH CARE SERVICES AND FACILITIES, AUTHORIZING THE INCREASE OF ITS MEDICAL PERSONNEL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 **SECTION 1.** The authorized bed capacity of the Mayor Hilarion
2 **A. Ramiro Sr. Medical Center (MHARSMC)** in the Province of
3 **Misamis Occidental** is hereby increased from five hundred (500) to
4 **one thousand (1,000) beds.** Any future increase in bed capacity shall
5 **be consistent with the hospital development plan** which shall be
6 **prepared by the Medical Center Chief of the MHARSMC** to reflect
7 **the developmental goals of the hospital,** and submitted to the
8 **Department of Health (DOH).**
- 9 **SEC. 2.** The existing professional health care services and
10 **facilities of the MHARSMC** are also hereby upgraded to conform

1 with and be commensurate to the increase in bed capacity as
2 provided for in Section 1 hereof.

3 SEC. 3. The existing workforce of the MHARSMC, which
4 includes doctors, nurses and support personnel, shall also be
5 increased correspondingly. The Secretary of the DOH shall, in
6 coordination with the Secretary of the Department of Budget and
7 Management (DBM) and the Commissioner of the Civil Service
8 Commission, and after consultation with the Medical Center Chief of
9 the MHARSMC, determine the additional new positions to be
10 created and filled up.

11 SEC. 4. The Secretary of Health shall immediately include in
12 the program of the DOH the implementation of this Act, the funding
13 of which shall be included in the annual General Appropriations Act.

14 SEC. 5. Within sixty (60) days from the approval of this Act,
15 the Secretary of Health, in consultation with the Secretary of the
16 DBM, shall promulgate the necessary rules and regulations for the
17 effective implementation of this Act.

18 SEC. 6. Republic Act No. 10865, otherwise known as the
19 "Mayor Hilarion A. Ramiro Sr. Medical Center Act", is hereby
20 amended, and all laws, rules and regulations which are inconsistent
21 with this Act are hereby repealed, amended or modified accordingly.

22 SEC. 7. This Act shall take effect fifteen (15) days after its
23 publication in the *Official Gazette* or in a newspaper of general
24 circulation.
