

## AN ACT CONVERTING THE BAGUIO CITY NATIONAL HIGH SCHOOL -HILLSIDE ANNEX IN BARANGAY HILLSIDE, BAGUIO CITY, INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS HILLSIDE NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

## EXPLANATORY NOTE

Article II, Section 17 of the 1987 Constitution provides that the State shall give priority to education. The Constitution further declares that the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all.

The Baguio City National High School offers quality and accessible education to high school students in Baguio. With only one mother school and two high school annexes, these annexes have become underequipped to cater to the growing number of enrollees each year. To address this problem, and to ensure that the youth of Baguio are provided quality and accessible education, the conversion of Baguio City National High School – Hillside Annex into an independent national high school is necessary.



## AN ACT CONVERTING THE BAGUIO CITY NATIONAL HIGH SCHOOL – HILLSIDE ANNEX IN BARANGAY HILLSIDE, BAGUIO CITY, INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS HILLSIDE NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

Section 1. *Conversion Into A National High School.* – The Baguio City National
 High School- Hillside Annex, in Barangay Hillside, Baguio City, is hereby converted
 into an independent national high school to be known as Hillside National High
 School.

Section 2. *Transfer of Assets and Liabilities.* – All personnel, assets, liabilities,
and records of Baguio City National High School – Hillside Annex are hereby
transferred to, and absorbed by, Hillside National High School.

8 Section 3. *Appropriations.* – The amount necessary for the implementation of 9 this Act shall be charged against the current year's appropriations of the Baguio City 10 National High School – Hillside Annex. Thereafter, such amount as may be necessary 11 for the operation and the maintenance of the Hillside National High School shall be 12 included in the annual General Appropriations Act.

Section 4. *Implementation*. – The Secretary of Education shall issue such
 rules and regulations as may be necessary to carry out the purposes of this Act.

Section 6. *Repealing Clause*. – All laws, decrees, orders, rules and regulations,
or other issuances or parts thereof inconsistent with the provisions of this Act are
hereby repealed or modified accordingly.

Section 7. Separability Clause. – If any portion or provision of this act is
 declared unconstitutional, the remainder of this Act or any provision not affected
 thereby shall remain in force and effect.

Section 5. *Effectivity*. – This Act shall take effect fifteen (15) days after its
publication in two (2) newspapers of general circulation.
