## RESOLUTION

EXPRESSING PROFOUND SYMPATHY AND SINCERE CONDOLENCES OF THE SENATE OF THE PHILIPPINES ON THE DEATH OF EDUARDO "DANDING" M. COJUANGCO, JR., CHAIRMAN AND CEO OF SAN MIGUEL CORPORATION, FORMER DIPLOMAT AND PUBLIC SERVANT

WHEREAS, the Senate of the Philippines has, on numerous occasions, recognized and honored distinguished Filipinos for their important contribution to their respective fields and for their positive impact and influence in the development of our society;

WHEREAS, Eduardo "Danding" M. Cojuangco, Jr., a former diplomat, public servant, industrialist, businessman, and sports patron, died on 16 June 2020, just a few days after he celebrated his 85<sup>th</sup> birthday;

WHEREAS, he is a well-known and respected businessman who served as Chairman and Chief Executive Officer of San Miguel Corporation, considered as the biggest food and beverage corporation in the Philippines and Southeast Asia, whose several businesses include San Miguel Brewery, Inc., the oldest brewery in Southeast Asia and the largest beer producer in the Philippines, and Ginebra San Miguel, Inc., the largest gin producer in the world by volume<sup>1</sup>;

WHEREAS, under his stewardship, San Miguel Corporation greatly expanded and transformed into a highly diversified conglomerate with valuable investments in

infrastructure, power and energy, oil refining and marketing, real estate, banking, among others;

WHEREAS, he and the companies he led engineered and supported economic growth of the country, provided thousands of jobs to Filipinos over the years, created opportunities towards the empowerment of communities, and committed to social development initiatives and charities;

WHEREAS, he was a public servant, who began his political career in his hometown in Paniqui, Tarlac as a Councilor, rose up the ranks and served as Municipal Vice Mayor, and eventually as Provincial Governor <sup>2</sup>;

WHEREAS, he was also appointed as ambassador to the United States of America by former President Ferdinand Marcos;

WHEREAS, he founded and sat as Chairman Emeritus of the Nationalist Peoples' Coalition (NPC), a "principled, progressive and compassionate political party that promotes national pride, builds national unity and advances national interest," and advocates "meaningful social changes and economic innovations<sup>3</sup>;"

WHEREAS, he guided the political party into becoming a relevant and active partner in nation-building, especially in improving the quality of lives of the people;"

WHEREAS, he was a steadfast supporter of basketball, who owned three teams in the Philippine Basketball Association (PBA) such as San Miguel Beermen, Barangay Ginebra San Miguel, and Magnolia Hotshots, and was a top benefactor of the De La Salle Green Archers men's basketball team in the University Athletic Association of the Philippines (UAAP)<sup>4</sup>;

WHEREAS, he was the force behind the creation and triumph of national basketball teams, which represented the country in international tournaments such as the Southeast Asian Games, Jones Cup, and Asian Basketball Confederation Championship and brought home glory, pride and honor<sup>5</sup>;
