

## RESOLUTION

DIRECTING THE APPROPRIATE SENATE COMMITTEE TO CONDUCT AN OF LEGISLATION, ON THE STATUS OF INQUIRY, IN AID THE **IMPLEMENTATION OF REPUBLIC ACT NO. 9512, OTHERWISE KNOWN AS** THE NATIONAL ENVIRONMENTAL AWARENESS AND EDUCATION ACT OF 2008, WITH THE END IN VIEW OF IDENTIFYING THE GAPS IN ITS **IMPLEMENTATION** AND ENSURING THE INTEGRATION OF **ENVIRONMENTAL EDUCATION IN THE SCHOOL CURRICULA AT ALL LEVELS** 

1 WHEREAS, Article II, Section 13 of the 1987 Constitution provides "[t]he State 2 recognizes the vital role of the youth in nation-building and shall promote and protect 3 their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in 4 the youth patriotism and nationalism, and encourage their involvement in public and 5 civic affairs";

6 WHEREAS, Article II, Section 16, of the Constitution further states that "[t]he 7 State shall protect and advance the right of the people to a balanced and healthful 8 ecology in accord with the rhythm and harmony of nature";

9 WHEREAS, the Paris Agreement on Climate Change, to which the Philippines is 10 a signatory, requires all Parties to strengthen the global response to the threat of 11 climate change;

WHEREAS, on 12 December 2008, Republic Act (R.A.) No. 9512, otherwise 12 known as the National Environmental Awareness and Education Act of 2008 was 13 enacted, which mandates the Department of Education (DepEd), the Commission on 14 Higher Education (CHED), the Technical Education and Skills Development Authority 15 (TESDA), the Department of Social Welfare and Development (DSWD), in coordination 16 with the Department of Environment and Natural Resources (DENR), the Department 17 of Science and Technology (DOST) and other relevant agencies to integrate 18 environmental education in its school curricula at all levels; 19

20 WHEREAS, in compliance with R.A. No. 9512, the DepEd issued Department 21 Order No. 52, s. 2011 on the "Strengthening Environmental Education in Public and 22 Private Schools" while the CHED issued Memorandum Order No. 33, s. 2009 to integrate environmental education particularly in the Civic Welfare and TrainingService component of the National Service Training Program;

WHEREAS, despite the passage of the National Environmental Awareness and Education Act of 2008 and other relevant environmental laws such as the Clean Air Act, the Philippine Clean Water Act, and the Ecological Solid Waste Management Act, there is still an apparent lack of awareness and commitment among Filipinos to conserve and protect the environment;

8 WHEREAS, Philippines ranked 3rd in deaths due to air pollution, according to 9 the World Health Organization (WHO). There were about 45.3 air pollution deaths per 10 100,000 Filipinos, based on the WHO study released in May 2018;

11 WHEREAS, the country likewise placed third among the world's largest 12 contributors of ocean plastic pollution, according to a 2015 study conducted by the 13 University of Georgia and reported by Ocean Conservancy and McKinsey Center for 14 Business and Environment;

WHEREAS, from 10.9 million hectares 45 years ago, the Philippine forest cover
has decreased to merely 7 million hectares as of 2015, according to the latest edition
of The State of Philippine Environment by IBON Foundation;

18 WHEREAS, according to the latest Generation Z: APAC report by Wunderman 19 Thompson Intelligence, natural disaster, climate change, and environmental pollution 20 are among the top five sources of worry of Filipino Gen Zs;

21 WHEREAS, these warning signs should prompt us to put forward our best 22 efforts in inculcating a sense of new and better "normal" that would provide the youth 23 of today and the next generation with a cleaner, greener, and equitable future;

24 WHEREAS, with continuous degradation of our environment, it is imperative 25 that we educate Filipinos especially the youth on the vital role of ensuring a balanced 26 environment in achieving sustainable development;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the Senate of the Philippines to direct the appropriate Senate Committee to conduct an inquiry, in aid of legislation, on the status of the implementation of Republic Act No. 9512, otherwise known as the National Environmental Awareness and Education Act of 2008, with the end in view of identifying the gaps in its implementation and ensuring that environmental education is integrated in the curricula at all levels.
