## AN ACT

UPGRADING THE LANAO DEL NORTE PROVINCIAL HOSPITAL, LOCATED IN THE MUNICIPALITY OF BAROY, LANAO DEL NORTE INTO A REGIONAL MEDICAL CENTER TO BE KNOWN AS THE LANAO DEL NORTE REGIONAL MEDICAL CENTER AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The Lanao Del Norte Provincial Hospital in the Municipality of Baroy, Province of Lanao Del Norte is hereby upgraded into a regional hospital to be known as the Lanao Del Norte Regional Medical Center (LDNRMC), under the direct supervision and control of the Department of Health (DOH).

 The bed capacity of LDNRMC shall be implemented in accordance with the hospital development plan that shall be prepared by the DOH.

- SEC. 2. The existing professional health care services and facilities are also hereby upgraded to conform with and be commensurate to the bed capacity increase as provided in Section 1 hereof.
- SEC. 3. The existing workforce of the LDNRMC, which includes doctors, nurses, and support personnel, shall also be increased correspondingly. The Secretary of Health shall, in coordination with the Secretary of Department of Budget and Management (DBM) and the Commissioner of the Civil Service Commission, and after consultation with the Medical Center Chief of LDNRMC, determine the additional new positions to be created and filled up.
- SEC. 4. The Secretary of Health shall immediately include in the program of the DOH the implementation of this Act, the funding of which shall be included in the annual General Appropriations Act.
