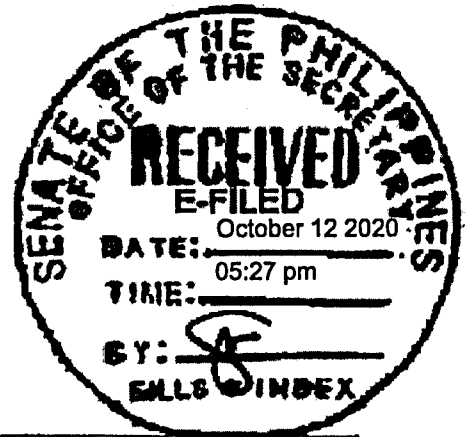

**AN ACT
CONVERTING SITIO CAMATCHILE IN BARANGAY MAWACAT,
MUNICIPALITY OF FLORIDABLANCA, PROVINCE OF PAMPANGA, INTO A
BARANGAY TO BE KNOWN AS BARANGAY CAMATCHILE AND FOR OTHER
PURPOSES**

EXPLANATORY NOTE

This bill seeks to convert Sitio Camatchile located in Barangay Nabuklod in the Municipality of Floridablanca into a barangay and therefore retain its identity based on its more or less permanent natural boundaries.

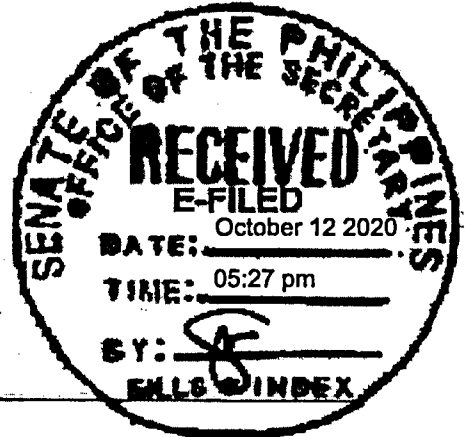
This is for the purpose of a more efficient and effective delivery of basic essential services as well as of better entitlement to an equitable share in the national internal revenue allotment of the Municipality of Floridablanca. This aims to ensure proper representation in local governance and to allow its communities to be provided with sufficient resources to be able to have the opportunity to self-govern.

In view of the foregoing, early passage of this bill is earnestly requested.

**AN ACT
CONVERTING SITIO CAMATCHILE IN BARANGAY MAWACAT,
MUNICIPALITY OF FLORIDABLANCA, PROVINCE OF PAMPANGA, INTO A
BARANGAY TO BE KNOWN AS BARANGAY CAMATCHILE AND FOR OTHER
PURPOSES**

*Be it enacted by the Senate and the House of Representatives of the Philippines
in Congress assembled:*

1 Section 1. Conversion of Sitio Camatchile Into a Barangay. – Sitio Camatchile in
2 Barangay Nabuklod, Municipality of Floridablanca, Province of Pampanga, is hereby
3 converted as a barangay, and therefore retain its identity based on its more or less
4 permanent natural boundaries. Its metes and bounds shall be surveyed, cost of which
5 shall be borne by the local government units concerned.

7 Sec. 2. *Barangay Officials.* – The first set of officials shall be appointed by the
8 Provincial Governor, in consultation with the Municipal Mayor and Representative of
9 the District and shall hold office until such time that their successors have been duly
10 elected and qualified.

12 Sec. 3. *Public Infrastructure and Facilities.* – All existing public infrastructure
13 and facilities for public use existing therein at the time of the approval of this Act are
14 hereby transferred without cost or compensation to and shall be administered by the
15 barangay.

1 **Sec. 4. Internal Revenue Allotment Shares.** – Barangay Camatchile shall be
2 entitled to Internal Revenue Allotment (IRA) shares pursuant to Section 285 of
3 Republic Act No. 7160, as amended, otherwise known as the Local Government Code
4 of 1991.

6 **Sec. 5. Effectivity Clause.** – This Act shall take effect fifteen (15) days after its
7 publication in at least two (2) newspapers of general circulation.
