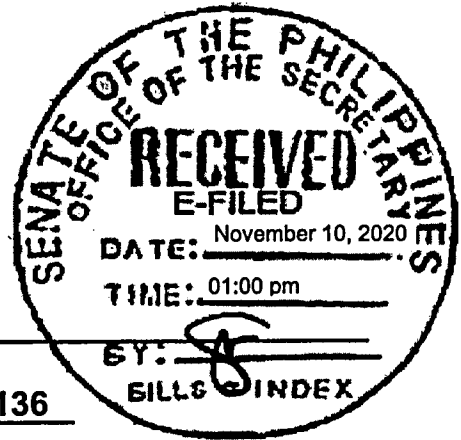



has considered the same and has the honor to report it back to the Senate with the recommendation that House Bill No. 1531 be approved without amendments.



*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The name of Pag-asa National High School in
2 Barangay Rawis, City of Legazpi, Province of Albay, is hereby
3 changed to Legazpi City National High School.

4 SEC. 2. The main campus of the Legazpi City National High
5 School shall continue to remain in its present location in Barangay
6 Rawis, City of Legazpi, Province of Albay.

7 SEC. 3. This Act shall take effect fifteen (15) days after its
8 publication in the *Official Gazette* or in a newspaper of general
9 circulation.
