AN ACT SEPARATING THE DALANAO ELEMENTARY
SCHOOL - DABBURAB-DALANAO EXTENSION IN
BARANGAY BACARRI, MUNICIPALITY OF PARACELIS,
MOUNTAIN PROVINCE FROM THE DALANAO
ELEMENTARY SCHOOL, CONVERTING IT INTO AN
INDEPENDENT ELEMENTARY SCHOOL TO BE KNOWN
AS WELLIE MACLINIC ELEMENTARY SCHOOL, AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The Dalanao Elementary School - Dabburab-
2 Dalanao Extension in Barangay Bacarri, Municipality of Paracelis,
3 Mountain Province is hereby separated from the Dalanao
4 Elementary School and converted into an independent elementary
5 school to be known as Wellie Maclinic Elementary School.

6 SEC. 2. All personnel, assets, liabilities and records of the
7 Dalanao Elementary School - Dabburab-Dalanao Extension are

1 hereby transferred to and absorbed by the Wellie Maclinic
2 Elementary School.

3 SEC. 3. The Secretary of Education shall immediately include
4 in the Department's program the operationalization of the Wellie
5 Maclinic Elementary School, the initial funding of which shall be
6 charged against the current year's appropriation of the Dalanao
7 Elementary School – Dabburab-Dalanao Extension. Thereafter, the
8 amount necessary for the continued operation of the school shall be
9 included in the annual General Appropriations Act.

10 SEC. 4. Within one hundred twenty (120) days after the
11 approval of this Act, the Secretary of Education shall formulate the
12 rules and regulations implementing the provisions of this Act.

13 SEC. 5. This Act shall take effect fifteen (15) days after
14 its publication in the *Official Gazette* or in a newspaper of
15 general circulation.
