AN ACT

ESTABLISHING AN INTEGRATED SCHOOL IN CIUDAD DE STRIKE, IN BARANGAY MOLINO I, CITY OF BACOOR, PROVINCE OF CAVITE TO BE KNOWN AS CIUDAD DE STRIKE INTEGRATED SCHOOL AND APPROPRIATING FUNDS THEREFOR

EXPLANATORY NOTE

Article II, Section 17 of the Philippine Constitution states:

"SECTION 17. The State shall give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development."

Further, Article 14, Section 1 mandates:

"Sec. 1. The State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all."

Moreover, the same Article, Section 2, paragraphs (1) and (2) provides:

"Sec. 2. The State shall:

- (1) Establish, maintain, and support a complete, adequate, and integrated system of education relevant to the needs of the people and society;
- (2) Establish and maintain a system of free public education in the elementary and high school levels. $x \times x''$

It is the duty of the State to provide an accessible, complete, adequate and integrated quality education to the youth because of their vital role in nation-building. Accordingly, this bill seeks to establish an integrated school to be located in Ciudad de Strike, Barangay Molino 1, City of Bacoor, Cavite.

The City of Bacoor has a population of 600,609 people according to the 2015 census of Philippine Statistics Authority (PSA) and in the Molino area alone, there are already 194,434 people residing in the area also as of 2015 Census of PSA.

Ciudad de Strike is a medium-rise housing project/resettlement for affected informal settler families (ISFs) residing along danger areas in greater Manila Area. It is envisioned to become a community with complete and accessible basic services especially education for the affected families.

The establishment of Ciudad de Strike Integrated School will not only recognize the need to provide quality education in the Ciudad de Strike community, but also in the nearby barangays of Molino 1, Molino 2, Molino 3, Molino 4, Molino 5, Molino 6, Molino 7, Bayanan, San Nicolas 1, San Nicolas 2 and San Nicolas 3 in the City of Bacoor.

Hence, urgent approval and passage of this bill is earnestly sought.



AN ACT

ESTABLISHING AN INTEGRATED SCHOOL IN CIUDAD DE STRIKE, IN BARANGAY MOLINO I, CITY OF BACOOR, PROVINCE OF CAVITE TO BE KNOWN AS CIUDAD DE STRIKE INTEGRATED SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- Section 1. *Establishment of Ciudad de Strike Integrated School.*-There is hereby established under the supervision of the Department of Education, an integrated school in Ciudad de Strike, Barangay Molino I, City of Bacoor, Province of Cavite, to be known as Ciudad de Strike Integrated School.
- Sec. 2. *Appropriations.*-The Secretary of Education shall immediately include in the Department's program the operationalization of the Ciudad de Strike Integrated School, the funding of which shall be included in the annual General Appropriations Act.
- 9 Sec. 3. *Implementation.* The Secretary of Education shall issue rules and regulations that may be necessary to carry out the purpose of this Act.
 - Sec. 4. *Effectivity.* This Act shall take effect fifteen (15) days after publication in the Official Gazette or two (2) newspapers of general circulation.
