AN ACT DECLARING APRIL 28 OF EVERY YEAR A SPECIAL WORKING HOLIDAY IN THE PROVINCE OF AURORA TO COMMEMORATE THE DEATH ANNIVERSARY OF DOÑA AURORA ARAGON-QUEZON

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. April 28 of every year is hereby declared a special
2 working holiday in the Province of Aurora to commemorate the
3 death anniversary of Doña Aurora Aragon-Quezon.

4 SEC. 2. The local government of the Province of Aurora shall
5 plan and implement appropriate ceremonies for the annual
6 observance of the Death Anniversary of Doña Aurora
7 Aragon-Quezon.

8 The Sangguniang Panlalawigan of the Province of Aurora
9 shall appropriate Five hundred thousand pesos (P500,000.00)
10 annually to carry out the objective of this Act. The amount may be
11 periodically increased to a reasonable level depending on certain
12 economic factors prevailing in the country.

1 **SEC. 3.** This Act shall take effect fifteen (15) days after its
2 publication in the *Official Gazette* or in a newspaper of general
3 circulation.
