AN ACT

INCREASING THE BED CAPACITY OF ILOCOS SUR DISTRICT HOSPITAL-MAGSINGAL IN THE MUNICIPALITY OF MAGSINGAL, PROVINCE OF ILOCOS SUR FROM TWENTY- FIVE (25) BEDS TO ONE HUNDRED (100) BEDS, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The authorized bed capacity of the Ilocos Sur District Hospital-
2 Magsingal (ISDHM) in the Municipality of Magsingal, Province of Ilocos Sur is hereby
3 increased from twenty- five (25) to one hundred (100) beds. Any future increase in bed
4 capacity shall be consistent with the hospital development plan that shall be prepared by
5 the Chief of the hospital and submitted to the Department of Health (DOH).

7 **SEC. 2.** The existing professional health care services and facilities of the
8 ISDHM are also hereby upgraded to conform with and be commensurate to the
9 increase in bed capacity as provided for in Section 1 hereof.

1 **SEC. 3** The existing workforce of the ISDHM, which includes doctors, nurses and
2 support personnel, shall also be increased correspondingly. The Secretary of the DOH
3 shall, in coordination with the Secretary of the Department of Budget and Management
4 and the Commissioner of the Civil Service Commission, and after consultation with the
5 Chief of Hospital, determine the additional new positions to be created and filled up.

7 **SEC. 4.** The Provincial Government of Ilocos Sur shall provide the necessary
8 funds to cover the maintenance and other operating expenses of the ISDHM. It shall
9 also appropriate funds for the human resource complement to support the increase in
10 bed capacity and the corresponding upgrading of its service facilities and professional
11 health care services. The Secretary of the DOH shall include in the Department's
12 subsidy program, support for the capital outlay requirements of the said district hospital.

14 **SEC. 5.** If any provision or part of this Act is declared unconstitutional, the
15 remaining parts or provisions not affected shall remain in full force and effect.

17 **SEC. 6.** All laws, executive orders, issuances, rules and regulations, inconsistent
18 with this Act are hereby repealed or modified accordingly.

20 **SEC. 7.** This Act shall take effect fifteen (15) days after its publication in the
21 *Official Gazette* or in a newspaper of general circulation.
