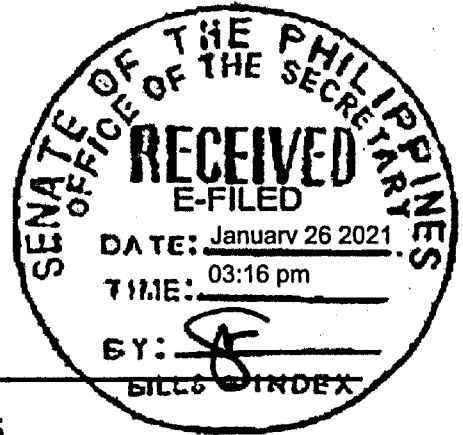

referred **House Bill No. 6731**, introduced by Representative Gasataya, entitled:

AN ACT
ESTABLISHING A GENERAL HOSPITAL IN THE CITY OF BACOLOD,
PROVINCE OF NEGROS OCCIDENTAL, TO BE KNOWN AS THE
BACOLOD CITY GENERAL HOSPITAL, AND APPROPRIATING FUNDS

and taking into consideration **Senate Bill No. 1647**, introduced by Senator Zubiri,
entitled:

AN ACT
ESTABLISHING A GENERAL HOSPITAL IN THE CITY OF BACOLOD,
PROVINCE OF NEGROS OCCIDENTAL, TO BE KNOWN AS THE

1647, be approved with the following amendments:

1. On page 2, after line 5, insert two new Sections, which shall read as follows:

"SEC. 5. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL, THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT."

"SEC. 6. ALL LAWS, EXECUTIVE ORDERS, ISSUANCES, RULES AND REGULATIONS INCONSISTENT WITH THIS ACT ARE HEREBY REPEALED OR MODIFIED ACCORDINGLY."

BY REPRESENTATIVE GASATAYA, PER COMMITTEE REPORT NO. 307

AN ACT ESTABLISHING A GENERAL HOSPITAL IN THE CITY OF BACOLOD, PROVINCE OF NEGROS OCCIDENTAL, TO BE KNOWN AS THE BACOLOD CITY GENERAL HOSPITAL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** There shall be established a tertiary general
2 hospital in the City of Bacolod, Province of Negros Occidental to be
3 known as the Bacolod City General Hospital (BCGH).

4 **SEC. 2.** The City Government of Bacolod shall provide funding
5 for the establishment, operation and maintenance of the BCGH.

6 **SEC. 3.** The Chief of Hospital of the BCGH shall submit to the
7 Department of Health (DOH) a development plan to reflect the
8 developmental goals of the hospital. The medical personnel, capital
9 outlays and budgetary needs for the operation of the BCGH shall
10 be based on the hospital development plan.

11 **SEC. 4.** The Secretary of the Department of Health (DOH)
12 shall include in the Department's subsidy program, its support for
13 the capital outlays of the hospital.

1 **SEC. 5.** The Secretary of Health, in consultation and
2 coordination with local government officials concerned, shall
3 promulgate the necessary rules and regulations for the effective
4 implementation of this Act within ninety (90) days from its
5 effectivity.

6 **SEC. 6.** This Act shall take effect fifteen (15) days after its
7 publication in the *Official Gazette* or in a newspaper of general
8 circulation.
