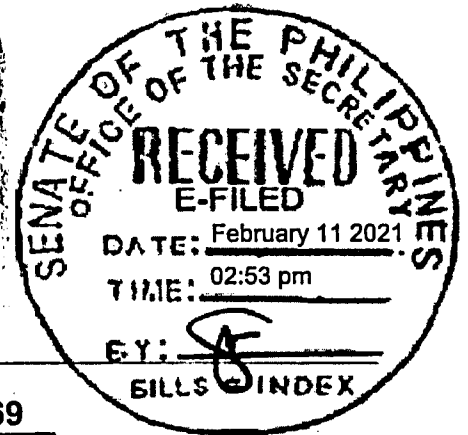

have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 7700, be approved without amendment.



AN ACT
REAPPORTIONING THE FIRST LEGISLATIVE DISTRICT OF THE CITY OF CALOOCAN
INTO TWO (2) LEGISLATIVE DISTRICTS

Be It enacted by the Senate and the House of Representatives of the Philippines In Congress assembled:

1 **SECTION 1.** The First Legislative District of the City of Caloocan is hereby reapportioned
2 into two (2) legislative districts to be designated as the First Legislative District and Third
3 Legislative District to take effect in the 2022 national and local elections.

5 a) The First Legislative District shall be composed of Barangays 1, 2, 3, 4, 77, 78,
6 79, 80, 81, 82, 83, 84, 85, 86, 132, 133, 134, 135, 136, 137, 138, 139, 140, 141,
7 142, 143, 144, 145, 146, 147, 148, 149, 150, 151, 152, 153, 154, 155, 156, 157,
8 158, 159, 160, 161, 162, 163, 164, 165, 166, 167, 168, 169, 170, 171, 172, 173,
9 174, 175, 176, and 177; and

11 b) The Third Legislative District shall be composed of Barangays 178, 179, 180, 181,
12 182, 183, 184, 185, 186, 187 and 188.

14 **SEC. 2.** The Commission on Elections shall issue the necessary implementing rules and
15 regulations within thirty (30) days after the effectivity of this Act.

16 **SEC. 3.** All laws, rules and regulations, which are inconsistent with this Act are hereby
17 repealed or amended accordingly.

18 **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the *Official*
19 *Gazette* or in a newspaper of general circulation.
