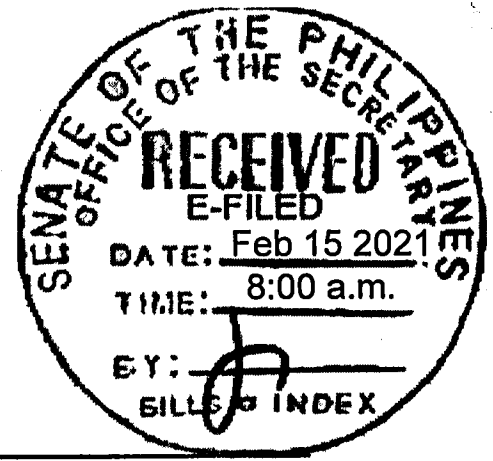

Recommending the approval of House Bill No. 2582 with amendments.

MR. PRESIDENT:

The Committees on Health and Demography, and Finance, to which was referred **House Bill No. 2582**, introduced by Representatives Abueg-Zaldivar, A.H.D.L. Tan, Arroyo, et al., entitled:

**AN ACT
INCREASING THE BED CAPACITY OF THE LYING-IN CLINIC IN
THE MUNICIPALITY OF RIZAL, PROVINCE OF PALAWAN FROM
TEN (10) BEDS TO TWENTY (20) BEDS, UPGRADING ITS SERVICE
FACILITIES AND PROFESSIONAL HEALTH CARE SERVICES,
AUTHORIZING THE INCREASE OF ITS MEDICAL PERSONNEL, AND
APPROPRIATING FUNDS THEREFOR**

have considered the same and have the honor to report back to the Senate with the recommendation that House Bill No. 2582 be approved with the following amendments:

1. On page 1, line 3, after the word "beds," add a second sentence, which shall read as follows:

"THE LYING-IN CLINIC SHALL BE NAMED AS THE JOSE P. RIZAL LYING-IN CLINIC."

2. On page 2, after line 5, insert a new Section, which shall read as follows:

"SEC. 4. ANY FUTURE INCREASE IN BED CAPACITY AND EXPANSION OF SERVICE CAPABILITY SHALL BE CONSISTENT

**WITH THE DEVELOPMENT PLAN OF THE HEALTH FACILITY,
WHICH SHALL BE PREPARED BY THE MANAGEMENT OF THE JOSE
P. RIZAL LYING-IN CLINIC."**

3. Renumber the succeeding section accordingly.

4. On page 2, line 6, delete the phrase "Provincial Government of Palawan" and replace it with the phrase "**CONCERNED LOCAL GOVERNMENT UNIT.**"

5. On page 2, line 14, insert two new Sections, which shall read as follows:

"SEC. 6. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL, THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT."

"SEC. 7. ALL LAWS, EXECUTIVE ORDERS, ISSUANCES, RULES AND REGULATIONS INCONSISTENT WITH THIS ACT ARE HEREBY REPEALED OR MODIFIED ACCORDINGLY."

6. Renumber the succeeding section accordingly.

AN ACT INCREASING THE BED CAPACITY OF THE LYING-IN CLINIC
IN THE MUNICIPALITY OF RIZAL, PROVINCE OF PALAWAN
FROM TEN (10) BEDS TO TWENTY (20) BEDS, UPGRADING ITS
SERVICE FACILITIES AND PROFESSIONAL HEALTH CARE
SERVICES, AUTHORIZING THE INCREASE OF ITS MEDICAL
PERSONNEL, AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The authorized bed capacity of the lying-in clinic
2 in the Municipality of Rizal, Province of Palawan is hereby increased
3 from ten (10) to twenty (20) beds.

4 SEC. 2. The existing service facilities and professional health
5 care services of the Rizal, Palawan Lying-in Clinic are hereby
6 upgraded to conform with and be commensurate to the bed capacity
7 as herein provided for.

8 SEC. 3. The existing workforce of the Rizal, Palawan Lying-in
9 Clinic shall be correspondingly increased. Upon prior consultation

1 with the management of the Rizal, Palawan Lying-in Clinic, the
2 Secretary of Health, in coordination with the Secretary of Budget and
3 Management and the Chairperson of the Civil Service Commission,
4 shall determine the additional plantilla positions to be created
5 pursuant to this Act.

6 SEC. 4. The Provincial Government of Palawan shall provide
7 the necessary funds for the maintenance and other operating
8 expenses of the lying-in clinic in the Municipality of Rizal. It shall
9 also appropriate funds for human resource complement to support
10 the increase in bed capacity and the corresponding upgrading of its
11 service facilities and professional health care services. The Secretary
12 of Health shall include in the Department's subsidy program, support
13 for the capital outlays of the said lying-in clinic.

14 SEC. 5. This Act shall take effect fifteen (15) days after its
15 publication in the *Official Gazette* or in a newspaper of general
16 circulation.

Approved.
