

# COMMITTEE REPORT NO. 171

Recommending the approval of House Bill No. 5870 with amendments.

Sponsor : Sen. Christopher Bong Go

#### MR. PRESIDENT:

The Committees on Health and Demography, and Finance, to which was referred **House Bill No. 5870**, introduced by Representative N. Gonzales II, entitled:

#### AN ACT

ESTABLISHING A THREE HUNDRED (300)-BED CAPACITY TERTIARY TRAINING AND GENERAL HOSPITAL IN BARANGAY MAUWAY, CITY OF MANDALUYONG TO BE KNOWN AS THE SENATE PRESIDENT NEPTALI A. GONZALES GENERAL HOSPITAL, AND APPROPRIATING FUNDS THEREFOR

have considered the same and have the honor to report back to the Senate with the recommendation that House Bill No. 5870 be approved with the following amendments:

On page 1, line 9, between the words "capacity," and "and", insert the phrase
"EXPANSION OF SERVICE CAPABILITY" and the punctuation mark comma (,).
On the same page, line 10, after the word "plan," insert a second sentence which shall read as follows:

# "THE HOSPITAL DEVELOPMENT PLAN SHALL INCLUDE A HOSPITAL SITE AND PHYSICAL FACILITIES DEVELOPMENT

# COVERING THE AREA OF THE MANDATED LOCATION AS PROVIDED IN THIS ACT."

3. On the same page, after line 10, insert a second paragraph to Sec. 2, which shall read as follows:

"THE HOSPITAL SITE SHALL BE AT LEAST TWO THOUSAND (2,000) SQUARE METERS WITHIN THE PREMISES OF THE NATIONAL CENTER FOR MENTAL HEALTH (NCMH). FOR THIS PURPOSE, THIS PROVISION SHALL BE CONSIDERED AN EXCEPTION TO THE PROVISIONS OF REPUBLIC ACT NO. 5260, AND OTHER RELATED LAWS, EXECUTIVE ORDERS, REGULATIONS AND ISSUANCES."

4. On page 2, line 8, insert two new Sections, which shall read as follows:

"SEC. 5. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL, THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT."

"SEC. 6. ALL LAWS, EXECUTIVE ORDERS, ISSUANCES, RULES AND REGULATIONS INCONSISTENT WITH THIS ACT ARE HEREBY REPEALED OR MODIFIED ACCORDINGLY."

5. Renumber the succeeding section accordingly.

- AN ACT ESTABLISHING A THREE HUNDRED (300)-BED GENERAL AND TERTIARY TRAINING CAPACITY CITY OF MAUWAY. HOSPITAL IN BARANGAY TO BE KNOWN AS THE SENATE MANDALUYONG GENERAL GONZALES NEPTALI Α. PRESIDENT HOSPITAL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There shall be established a three hundred I (300)-bed capacity tertiary training and general hospital to be 2 located in Nueve de Febrero St., Barangay Mauway, City of 3 Mandaluyong, to be known as the Senate President Neptah A. 4 Gonzales General Hospital (SPNGGH) under the direct supervision 5 and control of the Department of Health (DOH). 6

SEC. 2. The DOH shall develop a hospital development plan to reflect the developmental goals of the hospital. Any future 8 increase in bed capacity, and upgrading of health care services and 9 facilities shall be based on the hospital development plan. 10

1 SEC. 3. The Secretary of Health shall immediately include in 2 the Department's program the implementation of this Act, the 3 funding of which shall be included in the annual General 4 Appropriations Act.

5 SEC. 4. Within sixty (60) days from the effectivity of this Act. 6 the DOH shall issue the necessary rules and regulations for its 7 effective implementation.

8 SEC. 5. This Act shall take effect fifteen (15) days after 9 its publication in the *Official Gazette* or in a newspaper of 10 general circulation.
